Chapter 341

AN ACT Increasing the Salaries of the Clerks in the Office of Clerk of Courts in Oxford County.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 79, § 269, amended. That part of section 269 of chapter 79 of the revised statutes, which relates to clerk hire in the office of clerk of courts in Oxford county, is hereby amended to read as follows:

'for clerks in the office of clerk of courts, \$1,000 \$1,400.'
