## Chapter 29

**RESOLVE, Authorizing the State Tax Assessor to Convey Certain Interest of the State in Lands in Oxford County to Dr. W. B. Twaddle, of Bethel.**

State tax assessor authorized to convey certain lands. Resolved: That the state tax assessor be, and hereby is, authorized to convey to Dr. W. B. Twaddle, of Bethel, whatever interest the state has in 210 acres in lot 3, R. 5, and 87 acres in lot 4, R. 5 in A 1, Riley, Oxford county, containing 297 acres, more or less, for the sum of \$763.32.

## Chapter 30

**RESOLVE, Authorizing the State Tax Assessor to Convey Certain Interest of the State in Lands in Oxford County to Verne E. Mills of Bethel.**

State tax assessor authorized to convey certain land. Resolved: That the state tax assessor be, and hereby is, authorized to convey to Verne E. Mills, of Bethel, whatever interest the state has in part lot 1, R. 2, N. of County road, Fryeburg Academy grant, described in deed dated November 3, 1925, recorded in Oxford registry of deeds, book 377, page 482, with buildings in Mason township, Oxford county, containing 50 acres, more or less, for the sum of \$350.21.

## Chapter 31

**RESOLVE, Authorizing the State Tax Assessor to Convey Certain Interest of the State in Lands in Aroostook County to Fred B. Simpson, of Bangor.**

State tax assessor authorized to convey certain lands. Resolved: That the state tax assessor be, and hereby is, authorized to convey to Fred B. Simpson, of Bangor, whatever interest the state has in a tract in S. E. quarter, described in deed by George F. Underwood, et als, to F. Marion Simpson dated August 22, 1917, recorded in Aroostook Registry, book 301, page 102, with buildings, in T. 8, R. 4, W. E. L. S., Aroostook county, containing 56 acres, more or less, for the sum of \$73.68.
