Chapter 72

RESOLVE, Establishing a Daily Limit on Trout in Penobscot County.

Establishing a daily limit on trout in Penobscot county. Resolved: That the commissioner of inland fisheries and game, be and hereby is, authorized and directed to issue a rule and regulation establishing the daily bag limit of 15 trout per person per day from all waters of Penobscot county not having a lesser daily limit.

Effective August 13, 1947

Chapter 73

RESOLVE, Closing Wilson Stream in Piscataquis County to All Fishing.

Wilson stream closed to fishing. Resolved: That the commissioner of inland fisheries and game be, and hereby is, authorized and directed to issue a rule and regulation to close Wilson stream (salmon breeding ground), in Piscataquis county, from the top of Greeley Falls to Toby Fall, to all fishing for all seasons.

Effective August 13, 1947

Chapter 74

RESOLVE, Regulating Ice Fishing in Greenwood Pond in Elliottsville Plantation, Piscataquis County.

Ice fishing in Elliottsville plantation, regulated. Resolved: That the commissioner of inland fisheries and game be, and hereby is, authorized and directed to issue a rule and regulation closing Greenwood pond in Elliottsville plantation, Piscataquis county, to ice fishing.

Effective August 13, 1947

Chapter 75

RESOLVE, Closing Lost Pond in Penobscot County to Ice Fishing.

Lost pond closed to ice fishing. Resolved: That the commissioner of inland fisheries and game be, and hereby is, authorized and directed to issue a rule and regulation closing Lost pond in Township 7, Range 7, Penobscot county, to ice fishing.

Effective August 13, 1947
