## Chapter 133

### RESOLVE, in Favor of the Maine Distributors, Inc.

Maine Distributors, Inc.; reimbursed. Resolved: That there be, and hereby is, appropriated in favor of Maine Distributors, Inc., the sum of \$60 from the general highway fund for reimbursement of tolls paid by the Maine Distributors, Inc. to the Piscataquis Exchange Hotel, Greenville Junction.

## Chapter 134

### RESOLVE, Authorizing the Towns of Boothbay and Boothbay Harbor to Close Certain Waterways.

Boothbay and Boothbay Harbor authorized to close certain waterways. Resolved: That the towns of Boothbay and Boothbay Harbor, in the county of Lincoln, be, and hereby are, authorized to close the waterways between Boothbay Harbor and Sawyers Island with solid fill.

## Chapter 135

### RESOLVE, in Favor of David Peirce, of Hudson.

David Peirce; compensated. Resolved: That there be, and hereby is, appropriated the sum of \$450 to be paid to David Peirce, of Hudson, as a full and final settlement for his claim against the state for sheep and lambs killed by bear; said sum to be paid from the dog tax fund.

## Chapter 136

### RESOLVE, in Favor of Roby Littlefield, of Ogunquit.

Roby Littlefield; compensated. Resolved: That there be, and hereby is, appropriated the sum of \$200 to be paid to Roby Littlefield, of Ogunquit, as a full and final settlement for his claim against the state for loss of his garden and strawberry bed; said sum to be paid from the general highway fund.
