CHAP. 103

a reasonable percentage, as approved by the commissioner, of the capital cost thereof; provided, however, that in no case shall the payment to Brunswick by any tuition town under the contract exceed \$250 per tuition pupil per year.

- Sec. 5. Other contract terms; renewal. Contracts may be made for a period of not more than 5 years and may, if agreed upon, be made subject to modification of specified terms during the contract period; to cancellation by mutual agreement; and to renewal from time to time for a period not longer than 10 years from the original contract date; and contracts may contain such other terms and conditions, not inconsistent with this act, as may be agreed upon between the superintending school committees of the contracting towns and approved by the commissioner of education, on the basis of local conditions or experience; and shall contain any terms and conditions, not inconsistent with this act, which may be specified by vote in town meeting of a contracting party and approved by the commissioner.
- Sec. 6. Advisory board. An advisory board composed of I member from the superintending school committee of each tuition town, selected by the committee of which he is a member, is to represent the tuition towns in carrying out the administration of the contract in behalf of those towns with the superintending school committee of Brunswick.
- Sec. 7. Operative date. This act shall become operative upon its acceptance in town meeting by Brunswick and by any tuition town, and thereafter contracts hereby authorized will become operative when made for the several towns by their several superintending school committees and approved by the commissioner of education.
- Sec. 8. State aid. Nothing herein contained shall be taken as diminishing any payment of state school money or state aid for schools to which Brunswick or any tuition town is or may be entitled under general provisions of law. Nothing herein contained shall be taken as limiting the powers of any town mentioned herein to make contracts under the provisions of section 96 of chapter 37 of the revised statutes, as amended.

Emergency clause. In view of the emergency cited in the preamble, this act shall take effect when approved.

### Chapter 104

AN ACT Creating the Development Credit Corporation of Maine.

Be it enacted by the People of the State of Maine, as follows:

- Sec. 1. Corporators; corporate name; powers and privileges. Robert Braun, H. Nelson McDougall, E. Spencer Miller, Robert L. Getchell, Rolland E. Irish, Arthur F. Maxwell, Frederick G. Payne, William B. Skelton, George W. Lane, Jr., William S. Newell, Russell B. Spear, Harold F. Schnurle, William F. Wyman, Frederick R. Knauff, J. Stewart Upton, George D. Everett, Curtis M. Hutchins, Robert N. Haskell, Andrew J. Beck, Harry E. Umphrey, James M. Pierce, Raymond W. Davis and Harold R. Stone, or such of them as may vote to accept this charter, with their associates, successors and assigns, are hereby made a body corporate to be known as "Development Credit Corporation of Maine," and as such shall have the power to enact suitable by-laws and regulations, not inconsistent with the general laws of the state, and elect such officers as it deems desirable to effect its corporate purposes and be possessed of all the powers, privileges and immunities conferred on corporations by the general laws relating to corporations.
- Sec. 2. Principal office. The principal office and place of business in Maine is to be located in the city of Augusta, in the county of Kennebec, or as fixed by the directors, and the corporation may establish branch offices.
  - Sec. 3. Purposes and general powers. The purposes of this corporation
