RESOLVES

OF THE

STATE OF MAINE

As Passed by the Ninety-fourth Legislature

1949

to install a fish screen at John's pond in Davis township, in the county of Franklin, at the most suitable point to be determined by the commissioner; and be it further

Resolved: That such fish screen shall not be installed until such time as Mrs. Margaret B. Mason, of Rangeley, in the county of Franklin, or some responsible person or persons shall have paid in to the state treasury the amount necessary to install such screen; and shall have assumed, in a manner satisfactory to the commissioner, all liability for future maintenance of such screen, and the keeping of the same free from sticks, leaves and all debris.

Chapter 32

RESOLVE Regulating Fishing in Red River, in Aroostook County.

Fishing in Red river, in Aroostook county, regulated. Resolved: That the commissioner of inland fisheries and game be, and hereby is, authorized and directed to issue a rule and regulation closing the Red river, in Aroostook county, from Red River Falls to Poucheineer pond, after June 15th of each year, and establishing a daily bag limit of not more than 5 fish per person per day to be taken therefrom prior to June 15th of each year.

RESOLVE, Closing Chase Brook, in Township 13, Range 8, and Township 13, Range 7, in the County of Aroostook, to All Fishing.

Resolved: That the commissioner of inland fisheries and game be, and hereby is, authorized and directed to issue a rule and regulation closing Chase brook, in township 13, range 8, and township 13, range 7, in the county of Aroostook, to all fishing.

Chapter 34

RESOLVE, Closing Mantle Lake in the City of Presque Isle, Aroostook County, to all Fishing by Persons Over 17 Years of Age.

Mantle lake closed to certain fishing. Resolved: That the commissioner of inland fisheries and game be, and hereby is, authorized and directed to issue a rule and regulation closing Mantle lake in Presque Isle in the county of Aroostook to all fishing by persons over the age of 17 years.
