## Chapter 96

### RESOLVE, in Favor of Merlin C. Joy, of Clinton.

**Merlin C. Joy; credit for teaching service. Resolved:** That Merlin C. Joy, of Clinton, be given credit for 9  $\frac{1}{3}$  years of teaching rendered in Hebron Academy, Coburn Classical Institute, and Kents Hill Preparatory School, to be applied toward meeting requirements for a retirement benefit under the provisions of chapter 60 of the revised statutes, as amended.

## Chapter 97

### RESOLVE, Granting a Pension to Ethel S. Dick, of Gardiner.

**Teacher's pension granted to Ethel S. Dick. Resolved:** That a special pension be, and hereby is, granted to Ethel S. Dick, of Gardiner, comparable with that paid under the teachers' noncontributory pension law, based on 25 years of teaching service, as is now or may hereafter be provided by the legislature, to be paid quarterly from the general fund. Such pension shall begin on July 1, 1949 and continue until otherwise provided by the legislature.

## Chapter 98

### RESOLVE, Changing the Opening Date for Fishing in Lone Pond, in the Town of Waterboro, York County.

**Lone pond; opening date for fishing changed. Resolved:** That the commissioner of inland fisheries and game be, and hereby is, authorized and directed to issue a rule and regulation establishing May 1st as the opening date for fishing in Lone pond, in the town of Waterboro, York county.

### RESOLVE Proposing an Amendment to the Constitution to Empower the Legislature with the Consent of the People to Authorize the Issuance of State Bonds for any Purpose Stated in the Constitution.

**Constitutional amendment. Resolved:** Two-thirds of each branch of the legislature concurring, that the following amendment to the constitution of this state be proposed:
