## Chapter 167

### RESOLVE, in Favor of the City of Bath for Loss of Taxes.

City of Bath; appropriation. Resolved: That there be, and hereby is, appropriated, the sum of \$2,344.80 to be paid to the city of Bath, as a full and final settlement of all claims against the state for the loss of taxes on land and buildings formerly taxed by said city; said sum to be paid from the general highway funds.

Effective August 6, 1949

## Chapter 168

### RESOLVE, in Favor of Albert L. Winship of South Windham.

Albert L. Winship; compensated. Resolved: That there be, and hereby is, appropriated the sum of \$75 from the general fund of the state to be paid to Albert L. Winship, of South Windham, as a full and final settlement for his claim against the state for damage to his truck stolen from his barn by escapees from the reformatory at So. Windham.

Effective August 6, 1949

## Chapter 169

### RESOLVE in Favor of York Electrical Company.

York Electrical Company; reimbursed. Resolved: That there be, and hereby is, appropriated from the state police appropriation in favor of York Electrical Company the sum of \$995.21 for reimbursement of labor and materials furnished for cutting a right of way running a new telephone line, and installing new service on Ossipee Hill in Waterboro, by permission of the forestry department and the Maine state police department.

## Chapter 170

### RESOLVE in Favor of Myrtle Keefe, of Fryeburg.

Myrtle Keefe; reimbursed. Resolved: That there be, and hereby is, appropriated from the general fund of the state the sum of \$323.65 to reimburse Myrtle Keefe, of Fryeburg, executrix of the will of Harold W. Meserve, being the amount paid to the state of Maine for inheritance taxes in excess of what was legally due.
