**Chapter 100****RESOLVE, in Favor of Baxter State Park.**

**Baxter State Park; appropriation for. Resolved:** That there be, and hereby is, appropriated from the unappropriated surplus of the general fund the sum of \$11,000 for the 1953-1954 fiscal year for construction and improvement at Baxter State Park. Such expenditures shall be as recommended by the Baxter state park commission and approved by the governor and council. It is the intent of the legislature that the Baxter state park commission in their recommendations and the governor and council in their approval shall consider the total needs related to the overall development of Baxter State Park and in their final consideration give approval to such expenditures as shall accomplish the greatest possible development of this park facility within the limits of the appropriation provided herein.

Any balances at June 30, 1954 shall be carried forward to the 1954-55 fiscal year, but all unencumbered appropriation balances shall lapse June 30, 1955.

**Chapter 101****RESOLVE, in Favor of Western Maine Sanatorium.**

**Western Maine Sanatorium construction and improvement; appropriation for. Resolved:** That there be, and hereby is, appropriated from the unappropriated surplus of the general fund the sum of \$21,750 for the purpose of improvements to the sewer system and to the refrigeration system at Western Maine Sanatorium. Such expenditures shall be as recom-

## Chapter 102

**RESOLVE, in Favor of the Department of Adjutant General.**

**Improvements at Camp Keyes; appropriation for. Resolved:** That there be, and hereby is, appropriated from the unappropriated surplus of the general fund the sum of \$3,500 for the 1953-54 fiscal year and \$3,000 for the 1954-55 fiscal year. Such expenditures shall be as recommended by the adjutant general and approved by the governor and council. It is the intent of the legislature that the adjutant general in his recommendation and the governor and council in their approval shall consider the total needs of Camp Keyes area and in their final consideration give approval to such expenditures as shall accomplish the greatest possible improvement in camp facilities within the limits of the appropriation provided herein.

Any balances at June 30, 1954 shall be carried forward to the 1954-55 fiscal year, but all unencumbered appropriation balances shall lapse June 30, 1955.

**RESOLVE, in Favor of the Forestry Department.**

**Forestry department; appropriation for construction and improvements. Resolved:** That there be, and hereby is, appropriated from the unappropriated surplus of the general fund the sum of \$14,200 for the 1953-54 fiscal year and \$9,900 for the 1954-55 fiscal year for construction and improvement to the warden living quarters and other improvements related thereto. Such expenditures shall be as recommended by the forestry commissioner and approved by the governor and council. It is the intent of the legislature that the forestry commissioner shall present to the governor and council
