# Chapter 171

#### RESOLVE, in Favor of Vera A. Gordon, of West Sullivan.

Vera A. Gordon; retirement benefit. Resolved: That Vera A. Gordon, of West Sullivan, be given credit for an additional 6 months' teaching service so that she may be entitled to an additional retirement benefit under the provisions of chapter 60 of the revised statutes.

## Chapter 172

#### RESOLVE, Providing for State Pension for Rose LaPointe of Turner.

Rose LaPointe; state pension. Resolved: That a pension of \$40 per month be, and hereby is, granted to Rose LaPointe, of Turner, to be paid monthly from the appropriation for special legislative pensions. Such pension shall begin on July 1, 1953 and continue until otherwise provided by the legislature.

## Chapter 173

#### RESOLVE, to Reimburse Calais Regional Hospital for Aid to Edmund Lee.

Calais Regional Hospital; reimbursed. Resolved: That the sum of \$893.91 be, and hereby is, appropriated to be paid to the Calais Regional Hospital to reimburse said hospital for hospitalization of Edmund Lee; said sum to be paid from the general fund of the state.

#### RESOLVE, in Favor of E. Stanley Kitchin of Rumford.

E. Stanley Kitchin; credit for teaching service. Resolved: That E. Stanley Kitchin, of Rumford, be given credit for 10 years of teaching rendered in Hebron academy, to be applied toward meeting requirements for

### RESOLVE, Granting a Retirement Pension to Hugh A. Smith of Charleston.

Retirement pension granted to Hugh A. Smith. Resolved: That Hugh A. Smith, of Charleston, be given credit for 19 years of teaching service at Coburn Classical Institute so that he may be entitled to a retirement benefit under the provisions of chapter 60 of the revised statutes. Such re-tirement allowance shall not be payable until the said Hugh A. Smith has paid to the Maine State Retirement System the sum of \$920.

#### Chapter 176

#### RESOLVE, Closing Little Sebago Lake, Cumberland County, to Ice Fishing.

Little Sebago lake; ice fishing. Resolved: That the commissioner of inland fisheries and game be, and hereby is, authorized and directed to issue a rule and regulation to close Little Sebago lake, Cumberland county, to the taking of trout and salmon from October 1st to the following April 1st of each year. Said lake shall not be closed to ice fishing for perch and pickerel.

#### RESOLVE, in Favor of the Town of Liberty.

Town of Liberty; appropriation for. Resolved: That there be, and hereby is, appropriated in favor of the town of Liberty, the sum of \$1,337.24
