## Chapter 34

### RESOLVE Opening Sebasticook River, Somerset, Waldo and Kennebec Counties to Ice Fishing.

Sebasticook River; open to ice fishing. Resolved: That the Commissioner of Inland Fisheries and Game be, and hereby is, authorized and directed to issue a rule and regulation opening Sebasticook River from Moose Pond in Hartland to its confluence with the Kennebec River in Winslow to ice fishing under the general law.

## Chapter 35

### RESOLVE, Providing Relief for The American Legion Foundation, Holding and Endowment Corporation of the George Edwin Kirk Post, No. 25.

Liability for state inheritance tax abated. Resolved: That so much of an inheritance tax as may be now or hereafter payable by or assessable to the estate of Florence D. Young and The American Legion Foundation, Holding and Endowment Corporation of the George Edwin Kirk Post No. 25 of Bar Harbor, or either, as a result of a bequest under the will of Florence D. Young (who died December 1, 1931) to said The American Legion Foundation, Holding and Endowment Corporation of the George Edwin Kirk Post No. 25, is hereby abated.

## Chapter 36

### RESOLVE, Regulating Fishing in Trout Pond, Piscataquis County.

Fishing in Trout Pond; regulated. Resolved: That the Commissioner of Inland Fisheries and Game be, and hereby is, authorized and directed to issue a rule and regulation limiting Trout Pond, T. 3, R. 5, B. K. P., E. K. R., being Little Squaw Mountain Township, so called, in the County of Piscataquis, to fly fishing only, with a daily bag limit of 5 fish.

## Chapter 37

### RESOLVE, Regulating Fishing in Heald Pond, Somerset County.

Fishing in Heald Pond regulated. Resolved: That the Commissioner of Inland Fisheries and Game be, and hereby is, authorized and directed to issue a rule and regulation opening Heald Pond, Caratunk Plantation, Somerset County to fly fishing only with a daily bag limit of 5 fish.
