Chapter 54

RESOLVE, Designating the Interstate Highway System in Maine as Brian M. Jewett Memorial Highway.

Designation of Interstate Highway System. Resolved: That in recognition of the outstanding and unselfish service rendered by the late Brian M. Jewett to the State of Maine that the Interstate Highway System in Maine be named the "Brian M. Jewett Memorial Highway" and that appropriate plaques designating the name of the highway be erected and maintained by the State Highway Commission at such locations in rest areas as the State Highway Commission shall select.

Effective September 12, 1959

Chapter 55

RESOLVE, Authorizing Commissioner of Inland Fisheries and Game to Convey Certain Land in Fryeburg and Brownfield, Oxford County.

Commissioner of Inland Fisheries and Game; authorized to convey land. Resolved: That the Commissioner of Inland Fisheries and Game be, and is, authorized, on behalf of the State, to execute a deed to Philo T. Farnsworth, of Fort Wayne, Indiana, of such part of the land which was taken by eminent domain from said Farnsworth, in Fryeburg and Brownfield, as now appears to said commissioner to be not now needed by the State, including a strip of land bordering on route 5, the Pequaket Trail and extending 500 feet in the direction of the Saco River and parcels having their centers in midstream and being 100 feet in width containing Clay Brook and Little Saco River, from the first parcel herein mentioned to the joining of said streams with the Saco River.

Chapter 56

RESOLVE, Regulating Fishing in Ruffingham Meadow Game Management Area Flowage, Waldo County.

Fishing in Ruffingham Meadow Game Management Area Flowage; regulated. Resolved: That the Commissioner of Inland Fisheries and Game be, and hereby is, authorized and directed to issue a rule and regulation opening Ruffingham Meadow Game Management Area Flowage in Searsmont and Montville, Waldo County to ice fishing under the general laws from the time ice forms in the fall until March 31st.
