**Sec. 5. Activities.** During the biennium the committee shall direct itself toward the holding of a state conference for the purpose of developing facts and recommendations and preparing a report of the findings for presentation to the White House Conference on Aging and to the Governor and Legislature.

**Sec. 6. Appropriation.** There is appropriated from the General Fund of the State the sum of \$15,000 for the fiscal year ending June 30, 1962 and the sum of \$15,000 for the fiscal year ending June 30, 1963 to be expended in the furtherance of the objectives of this act; the breakdown of which shall be as follows:

## Chapter 217

**AN ACT Appropriating Funds for Ferry Service for Long Island Plantation.**

*Be it enacted by the People of the State of Maine, as follows:*

**Appropriation.** There is appropriated to the Maine Port Authority from the General Fund of the State the sum of \$12,000 for the fiscal year ending June 30, 1962 and \$12,000 for the fiscal year ending June 30, 1963 to provide adequate ferry service to and from Long Island Plantation.

## Chapter 218

**AN ACT Authorizing Funds for Construction of Machias Landing Field.**

*Be it enacted by the People of the State of Maine, as follows:*

**Sec. 1. Funds for Machias landing field.** In order to provide a landing facility for the Machias area, the Town of Machias and any other municipality in Washington County is authorized to pay over to the Aeronautics Commission public funds not exceeding \$1,858 for the construction of a turf landing field at Machias.

**Sec. 2. County funds authorized.** The treasurer of Washington County is authorized to pay over to the Aeronautics Commission a sum of money not exceeding \$10,000 to finance a part of said construction.
