**CHAP. 26** 

#### Chapter 23

RESOLVE, Regulating Fishing in Dodge Pond, Franklin County.

Fishing in Dodge Pond, regulated. Resolved: That the Commissioner of Inland Fisheries and Game is authorized and directed to issue a rule and regulation to open Dodge Pond, in the Town of Rangeley, County of Franklin, to fishing under the general law and to prohibit the use or possession of live fish as bait.

Effective September 16, 1961

#### Chapter 24

RESOLVE, Regulating Ice Fishing on Big Pond, Dexter, Penobscot County.

Ice fishing on Big Pond, regulated. Resolved: That the Commissioner of Inland Fisheries and Game is authorized and directed to issue a rule and regulation closing that part of Lake Wassookeag in Dexter, Penobscot County, known as the Big Pond, being that part of said Lake Wassookeag lying westerly and southerly of the Guy H. Hall Memorial Bridge on the road leading from said Dexter to Sangerville, Route #23, so called, to ice fishing from the time ice forms in the fall until February 1st.

Effective September 16, 1961

#### Chapter 25

RESOLVE, Regulating Fishing in Squaw Pond, T3, R5, Piscataquis County.

Fishing in Squaw Pond, regulated. Resolved: That the Commissioner of Inland Fisheries and Game is authorized and directed to issue a rule and regulation opening Squaw Pond, T<sub>3</sub>, R<sub>5</sub>, Piscataquis County, to fishing under the general law and establishing a daily limit of 5 trout and prohibiting the use or possession of live fish as bait.

Effective September 16, 1961

#### Chapter 26

RESOLVE, Regulating Fishing in Certain Waters in Piscataquis County.

Fishing in certain waters in Piscataquis County; regulated. Resolved: That the Commissioner of Inland Fisheries and Game is authorized and directed to issue a rule and regulation opening Boyds Lake, Orneville; Ebeemee Ponds, East and West, T. 5, R. 9 and Brownville and Ebeemee Pond, Upper, T. 4, R. 9, and T. B., R. 10 to fishing, except for trout, salmon or togue, during the month of October.
