Chapter 31

RESOLVE, Authorizing State to Convey Certain Land to Cumberland County.

State of Maine to convey land in Windham; authorizing. Resolved: That for the purpose of providing land for the erection of a Civil Defense and Public Safety Control Center, the Governor and Council are authorized and directed to convey to the County of Cumberland for the sum of \$1, the interest of the State in a certain lot or parcel of land situated in the Town of Windham in said county, now part of the grounds of the State Reformatory for Men.

Said parcel of land is described as follows: Beginning at the most northerly corner of land of the State of Maine on the southwesterly side of High Street; thence southwesterly following the northwesterly boundary line of land of said State of Maine, 560 feet to a point; thence southeasterly, parallel with the southwesterly line of High Street, 350 feet to a point; thence northwesterly, parallel to the first course, 560 feet to High Street; thence northwesterly by High Street 350 feet to the point of beginning.

Chapter 32

RESOLVE, Opening Baker Pond, Somerset County, to Fly Fishing.

Baker Pond, Somerset County, fishing regulated. Resolved: That the Commissioner of Inland Fisheries and Game is authorized and directed to issue a rule and regulation opening Baker Pond in Tomhegan Township, T. 1, R. 2, Somerset County, to fly fishing.

Chapter 33

RESOLVE, Authorizing the Director of the Bureau of Public Improvements to Convey Certain Land in Hallowell.

Bureau of Public Improvements; authorized to convey certain land. Resolved: That the Director of the Bureau of Public Improvements, in the name of the State of Maine, is authorized and directed to execute and convey by quit-claim deed to Lawrence Slack of Hallowell, Kennebec County, for the sum of \$100, a certain lot or parcel of land situated in said Hallowell, bounded and described as follows:

Beginning at the easterly corner of land of the grantee at the side line of Pleasant Street; thence by the land of the grantee westerly 126 feet; thence northerly 20 feet; thence easterly 126 feet to the side line of said Pleasant Street; thence by said side line of Pleasant Street 20 feet to the place of beginning.
