'Sec. 26. Dogs in unorganized territories. The Commissioner of Agriculture is authorized to appoint a dog recorder or recorders in unorganized territories. Said recorders shall list all dogs 4 months old or over, owned or kept by any inhabitants on April 1st, setting the number and sex thereof opposite the names of their respective owners and keepers. Said returns shall be made to the Commissioner of Agriculture on or before the first day of June following.

The dog recorder shall issue licenses, receive the money therefor and pay the same to the Treasurer of State who shall credit the same to the General Fund. Such recorders shall keep a record of all licenses issued by them, with the names of the owners or keepers of dogs licensed and the sex, registered numbers and description of all such dogs. The sex, registered number and description shall not be required of dogs covered by a kennel license.

Fee for the recorder's service shall be determined by the Commissioner of Agriculture.'

## Chapter 161

### AN ACT Relating to How Motor Vehicle Number Plates are Fastened.

*Be it enacted by the People of the State of Maine, as follows:*

**Sec. 1.** R. S., c. 22, § 18, amended. The 2nd sentence of the 3rd paragraph of section 18 of chapter 22 of the Revised Statutes is amended to read as follows:

'Each number plate displayed shall be horizontal ~~and shall be so fastened as not to swing~~ and its lower edges shall be at least 12 inches from the ground.'

**Sec. 2.** R. S., c. 22, § 18, amended. Section 18 of chapter 22 of the Revised Statutes, as amended, is further amended by adding after the 3rd paragraph, a new paragraph, as follows:

'Farm trucks, or any vehicle used for hauling forest products and required by law to be registered, may attach the number plate by means of a rigid or semi-rigid bracket designed so as to allow the plate to swing freely.'

## Chapter 162

### AN ACT Revising the Savings Bank Law.

*Be it enacted by the People of the State of Maine, as follows:*

**Sec. 1.** R. S., c. 59, § 19-C, sub-§ I, amended. Subsection I of section 19-C of chapter 59 of the Revised Statutes, as enacted by section 1 of chapter 379 of the public laws of 1961, is amended by inserting after the 3rd sentence, a new sentence, as follows:
