Chapter 240

AN ACT Adding the Maine Motor Vehicle Dealer Registration Board to the State Agencies Subject to the Administrative Code.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 20-A, § 1, sub-§ I, amended. Subsection I of section 1 of chapter 20-A of the Revised Statutes, as enacted by section 1 of chapter 394 of the public laws of 1961, and as amended, is further amended by adding at the end thereof, the following:

'Maine Motor Vehicle Dealer Registration Board.'

Sec. 2. R. S., c. 22, § 25, amended. The 2nd sentence of section 25 of chapter 22 of the Revised Statutes, as amended by section 1 of chapter 76 of the public laws of 1957, is further amended to read as follows:

'The ~~board is further empowered to~~ **Hearing Officer** as designated in chapter 20-A may order the Secretary of State to suspend or revoke, in accordance with ~~the provisions of~~ this chapter, any motor vehicle dealer or transit registration plates already issued.'

Chapter 241

AN ACT to Revise the Laws Relating to Real Estate Brokers and Salesmen.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 84, § 1, amended. The 2nd paragraph of section 1 of chapter 84 of the Revised Statutes, as amended by section 1 of chapter 138 of the public laws of 1961, is further amended to read as follows:

'Each member of the commission shall receive as full compensation for each day actually spent on the work of said commission the sum of ~~\$15~~ **\$20** and his actual and necessary expenses incurred in the performance of duties pertaining to his office.'

Sec. 2. R. S., c. 84, § 1, amended. Section 1 of chapter 84 of the Revised Statutes, as amended, is further amended by adding at the end, a new paragraph, to read as follows:

'The commission shall investigate any violation of this chapter by licensees and non-licensees and report its findings from time to time to the office of the Attorney General or appropriate county attorney for prosecution.'

Sec. 3. R. S., c. 84, § 2-A, sub-§ I, ¶¶ A and B, amended. Paragraphs A and B of subsection I of section 2-A of chapter 84 of the Revised Statutes, as enacted by section 2 of chapter 138 of the public laws of 1961, are amended to read as follows:
