## Chapter 24

### RESOLVE, Regulating Fishing in Dow Pond, Piscataquis County.

**Fishing in Dow Pond; regulated. Resolved:** That the Commissioner of Inland Fisheries and Game be authorized and directed to issue a rule and regulation opening Dow Pond, in the Town of Sebec, Piscataquis County, to fishing under the general law and establishing a daily bag limit of 5 fish and prohibiting the use or possession of live fish as bait.

Effective September 21, 1963

## Chapter 25

### RESOLVE, Regulating Fishing in Hatcase Pond in Penobscot and Hancock Counties.

**Fishing in Hatcase Pond; regulated. Resolved:** That the Commissioner of Inland Fisheries and Game is authorized and directed to issue a rule and regulation to prohibit fishing in that portion of Hatcase Pond lying generally northerly of the red posts set on opposite shores at the narrowest point in the cove at the north end of said Hatcase Pond; for further identification, such narrowest point is approximately 500 yards south of the pumping station of the Brewer Water District.

## Chapter 26

### RESOLVE, Regulating Fishing in Kennebago River, Franklin County.

**Fishing in Kennebago River; regulated. Resolved:** That the Commissioner of Inland Fisheries and Game be authorized and directed to issue a rule and regulation regulating fishing in Kennebago River, Franklin County, as follows:

Open to fly fishing only from Big Island Pond to Little Kennebago Lake, daily limit of 5 fish;

From Little Kennebago Lake to Big Kennebago Lake, open until September 30th, fly fishing only, daily limit of 5 fish, all tributaries closed;

From outlet of Big Kennebago Lake, down to the second dam (power dam), open until September 30th, fly fishing only, daily limit of 5 fish;

Below second dam (power dam), fly fishing only, open until September 30th, daily limit of one fish, tributaries closed.
