## Chapter 27

### RESOLVE, Authorizing the Building of a Private Road Across Portion of Mousam Lake, York County.

**Building of a private road authorized. Resolved:** That Henry P. Acker of Springvale, County of York, is authorized to build and maintain a private road across a portion of Mousam Lake, York County, said private road to extend from land owned by Henry P. Acker on the mainland of Knox Cove to an island owned by Henry P. Acker about 50 feet from the mainland in a westerly direction.

## Chapter 28

### RESOLVE, Limiting Carrabassett River to Fly Fishing Only.

**Limiting Carrabassett River; fly fishing. Resolved:** That the Commissioner of Inland Fisheries and Game be authorized and directed to issue a rule and regulation limiting Carrabassett River, from its source in Crockertown Township, Franklin County, to a point at East New Portland, Somerset County, where route 146 crosses the river, to fly fishing only.

## Chapter 29

### RESOLVE, for Removal of Old Bridge Across Mattawamkeag River in Haynesville.

**Removal of old bridge across Mattawamkeag River in Haynesville. Resolved:** That the State Highway Commission is authorized to remove the old bridge across the Mattawamkeag River in Haynesville Village, this bridge being located on a road which was formerly a part of U. S. Route 2-A in Haynesville Village.

## Chapter 30

### RESOLVE, Regulating Fishing for Bass in Nequasset Pond, Sagadahoc County.

**Nequasset Pond; fishing regulated. Resolved:** That the Commissioner of Inland Fisheries and Game be authorized and directed to issue a rule and regulation that there be no minimum length or bag limit on the taking of black bass from Nequasset Pond, Woolwich, Sagadahoc County and open season and means of taking bass correspond to general law for trout and salmon.
