## Chapter 31

### **RESOLVE, Regulating Fishing on Part of Moose River, Somerset County.**

**Fishing on part of Moose River, regulated. Resolved:** That the Commissioner of Inland Fisheries and Game is authorized and directed to issue rules and regulations establishing on Moose River from Brassua Lake to Moosehead Lake in Rockwood Strip and Taunton, Raynham Grant, T1 R1, Somerset County, the opening date for fishing as May 1st of each year, open under the general laws from May 1st to September 15th of each year, closing to all but fly fishing with a daily limit of one fish from September 16th to September 30th of each year.

## Chapter 32

### **RESOLVE, Regulating Ice Fishing in Great Pond, Cumberland County.**

**Fishing in Great Pond, Cumberland County; regulated. Resolved:** That the Commissioner of Inland Fisheries and Game is authorized and directed to make a rule and regulation to open Great Pond in the Town of Cape Elizabeth, in the County of Cumberland, to ice fishing from the time ice forms until March 31st.

## Chapter 33

### **RESOLVE, Regulating Fishing in Cross Lake, Aroostook County.**

**Fishing in Cross Lake, T16 R5, T17 R5, Aroostook County, regulated. Resolved:** That the Commissioner of Inland Fisheries and Game is authorized and directed to issue a rule and regulation opening Cross Lake, T16 R5, T17 R5, Aroostook County, to ice fishing at night from sunset to sunrise for cusk from the time ice forms in the fall until March 31st of each year and also prohibiting the use or possession of live fish as bait during the ice fishing season.

## Chapter 34

### **RESOLVE, Regulating Fishing in Tingley Brook and Tributary, Jose Brook, Kennebec County.**

**Fishing in Tingley Brook and tributary; regulated. Resolved:** That the Commissioner of Inland Fisheries and Game is authorized and directed to issue a rule and regulation establishing in Tingley Brook, and tributary Jose Brook, Towns of Readfield and Mt. Vernon, Kennebec County, north of Route 17 where it crosses Tingley Brook in Readfield, a no length limit on trout.
