Chapter 50

RESOLVE, Regulating Fishing in Jones Pond, Hancock County.

Fishing in Jones Pond; regulated. Resolved: That the Commissioner of Inland Fisheries and Game is authorized and directed to issue a rule and regulation opening Jones Pond, West Gouldsboro, to fishing for all species except salmon, trout and togue during the month of October each year.

Effective September 21, 1963

Chapter 51

RESOLVE, Regulating Fishing in Moose River, Somerset County.

Fishing in Moose River, Somerset County; regulated. Resolved: That the Commissioner of Inland Fisheries and Game is authorized and directed to issue a rule and regulation opening Moose River from confluence of Holeb Stream to Attean Pond in Holeb (T6 R1), Attean (T5 R1), T5 R7, T4 R7, Somerset County, to fishing with artificial lures only, with a 5-fish daily limit from April 1st to August 31st of each year.

Effective September 21, 1963

Chapter 52

RESOLVE, Granting a Right of Way by the State to Catherine L. Howell of Cape Elizabeth.

Granting of right of way to Catherine L. Howell. Resolved: That the Chairman of the State Park and Recreation Commission is authorized to grant to Catherine L. Howell, of Cape Elizabeth, her heirs and assigns, a right-of-way over an existing semi-circular roadway at the easterly end of Two Lights State Park.

Effective September 21, 1963

Chapter 53

RESOLVE, Regulating Fishing in Pleasant Pond, Island Falls and Township 4 Range 3, Aroostook County.

Fishing in Pleasant Pond; regulated. Resolved: That the Commissioner of Inland Fisheries and Game is authorized and directed to issue a rule and regulation on Pleasant Pond, Island Falls and T4 R3, Aroostook County, permitting the use of 3 single pointed hooks on one line for smelt fishing only, said hooks to be not less than 4 inches apart.

Effective September 21, 1963
