# One Hundred and Third Legislature 1967

#### Chapter 154

AN ACT Reclassifying Certain Tidal Waters in York County.

Be it enacted by the People of the State of Maine, as follows:

- Sec. 1. R. S., T. 38, § 370, amended. Subsection 1, paragraphs F and G, of section 370 of Title 38 of the Revised Statutes, under the caption Tidal Waters, York County, are amended to read as follows:
  - F. From the most easterly point of land on the Biddeford mainland to a point directly west of the most northerly point of land on Basket Island, including tidewaters of "The Pool"—Class SC SB-1.
  - **G.** Tidewaters from a point directly west of the most northerly point of land on Basket Island to head of tide on the Saco River estuary—Class SD SC.
- Sec. 2. R. S., T. 38, § 370, amended. Subsection 7, paragraph B, of section 370 of Title 38 of the Revised Statutes, under the caption Tidal Waters, York County, is amended to read as follows:
  - B. Saco River estuary from head of tide to the Camp Ellis breakwater—Class SD SC.

### Chapter 155

AN ACT Reclassifying Certain Tidal Waters of Waldo County.

Be it enacted by the People of the State of Maine, as follows:

- R. S., T. 38, § 370, amended. Subsection I, paragraph C, of section 370 of Title 38 of the Revised Statutes, under the caption Tidal Waters, Waldo County, is amended to read as follows:
  - **C.** Tidewaters between a point opposite the swimming pool at **Belfast** city park and the mouth of Goose River, except for portions otherwise classified or described—Class SD SC.

## Chapter 156

AN ACT Classifying Certain Waters of St. Croix River Watershed.

Be it enacted by the People of the State of Maine, as follows:

R. S., T. 38, § 368, sub-§ 2, additional. That part of section 368 of Title 38 of the Revised Statutes, which relates to the St. Croix River Basin, is amended by adding a new subsection 2 to read as follows:

PUBLIC LAWS, 1967

CHAP. 158

2. Waters of the St. Croix River Watershed, within the State of Maine, not otherwise classified, including those of the Main Stem of the St. Croix River and of Monument Brook on the Maine side of the international boundary above the head of tide — Class C.

Effective October 7, 1967

#### Chapter 157

AN ACT Prohibiting Use of Certain Names by Partnerships.

Be it enacted by the People of the State of Maine, as follows:

R. S., T. 31, § 6, additional. Title 31 of the Revised Statutes is amended by adding a new section 6, to read as follows:

#### § 6. Prohibition of certain names

No person or persons, partnership or other entity engaged in any business, except a corporation, shall adopt a name for such business which contains the words "corporation", "incorporated" or "limited", or any abbreviation of any such words.

## Chapter 158

AN ACT Relating to Validation of Defects in Foreclosure of Real Estate Mortgages.

Be it enacted by the People of the State of Maine, as follows:

R. S., T. 33, § 353, amended. Section 353 of Title 33 of the Revised Statutes, as amended by chapter 120 of the public laws of 1965, is further amended by adding at the end thereof the following:

In all cases of foreclosure of real estate mortgages by publication, a certificate of the publication of foreclosure made by the mortgagee or by an officer of the mortgagee, if a corporation, recorded on or before January 1, 1947 shall be prima facie evidence of the publication of foreclosure to the same extent as if the certificate had in fact been made by the register of deeds and recorded; such certificates made by the mortgagee or by an officer of the mortgagee, if a corporation, and recorded on or before January 1, 1947 shall have the same force and effect as if made by the register of deeds, in the first instance, and are hereby validated.
