## Chapter 71

**RESOLVE, Authorizing a Study of the Operational Aspects of the Superior and Supreme Courts.**

**Funds for study of Supreme Judicial and Superior Courts; appropriation. Resolved:** That the sum of \$20,000 is appropriated from the Unappropriated Surplus of the General Fund to the Judicial Council; and be it further

**Resolved:** That such sum be expended by the Judicial Council to defray the expenses of a study of the operational aspects of the Supreme Judicial and Superior Courts, particularly in the area of finances, facilities and personnel; and be it further

**Resolved:** That this appropriation shall not lapse but shall remain a continuing carrying account until the purposes of this resolve have been completed; and be it further

**Resolved:** That the Judicial Council shall make a progress report to the 105th Legislature.

## Chapter 72

**RESOLVE, to Reimburse Charles A. Holden of Portland as Agent of Conservator of Casco Mercantile Trust Company.**

**Charles A. Holden; reimbursed. Resolved:** That there is appropriated the sum of \$3,000 from the General Fund to Charles A. Holden of Portland for one year's salary as agent of Harry M. Verrill, Conservator of The Casco Mercantile Trust Company of Portland, in liquidating assets of the company and depositing with the State approximately \$65,000 which sum escheated to the State.
