**Sec. 2. R. S., T. 21, § 134, sub-§ 3, amended.** Subsection 3 of section 134 of Title 21 of the Revised Statutes, is amended to read as follows:

3. **Restrictions during change of enrollment.** A voter may not vote at a caucus or primary election within 6 3 months after filing an application to change his enrollment, except as provided in subsection 4.

**Sec. 3. R. S., T. 21, § 135, sub-§ 1, amended.** Subsection 1 of section 135 of Title 21 of the Revised Statutes is amended to read as follows:

1. **Limitation.** A voter may not file a request to withdraw his enrollment for 6 3 months after the date on which he enrolled.

## Chapter 4

### **AN ACT Relating to Daily Bag Limit of Certain Fish Taken by Ice Fishing.**

*Be it enacted by the People of the State of Maine, as follows:*

**R. S., T. 12, § 2553, amended.** The 4th paragraph of section 2553 of Title 12 of the Revised Statutes, as enacted by section 2 of chapter 317 of the public laws of 1969, is amended to read as follows:

In waters open to ice fishing no person shall take, catch or kill in any one day or have in possession at any time more than 5 7½ pounds in the aggregate of the trout, salmon, togue and black bass species unless the last fish caught increases the combined weight to more than 5 7½ pounds.

## Chapter 5

### **AN ACT Relating to Open Season for Bass by Ice Fishing.**

*Be it enacted by the People of the State of Maine, as follows:*

**R. S., T. 12, § 2651, amended.** Section 2651 of Title 12 of the Revised Statutes, as amended, is further amended by adding at the end the following new paragraph:

Unless otherwise provided by rule and regulation, it shall be lawful to take black bass through the ice during the same period that it is lawful to take salmon and trout.
