## Chapter 126

### AN ACT Relating to Certificate for Transportation of House Trailers.

*Be it enacted by the People of the State of Maine, as follows:*

**R. S., T. 29, § 336, sub-§ 4, amended.** The first sentence of subsection 4 of section 336 of Title 29 of the Revised Statutes, as repealed and replaced by section 6 of chapter 400 of the public laws of 1969, is amended to read as follows:

No house trailer, as defined in Title 36, section 1481, shall be moved over the highways of this State through use of dealer plates or transporter plates ~~issued by this State~~, unless the operator of the vehicle hauling such trailer has in his possession a written certificate from the tax collector of the municipality from which the trailer is being moved, identifying the trailer and stating that all property taxes applicable to the trailer, including those for the current tax year, have been paid, or that the trailer is exempt from such taxes.

## Chapter 127

### AN ACT Revising the Law Relating to Traveling Libraries.

*Be it enacted by the People of the State of Maine, as follows:*

**Sec. 1. R. S., T. 27, § 3, amended.** Section 3 of Title 27 of the Revised Statutes is amended to read as follows:

#### § 3. Books lent

Under such rules and regulations as the State Librarian may prescribe, books and documents may be lent to any responsible resident of the State. Such rules and regulations may include the charge ~~for lending traveling libraries and~~ for overdue books and documents.

**Sec. 2. R. S., T. 27, § 34, amended.** Section 34 of Title 27 of the Revised Statutes is amended to read as follows:

#### § 34. Library extension

The State Librarian shall maintain a section of library extension which shall carry on such activities as are enumerated in sections ~~35 and 36 and~~ 37.

**Sec. 3. R. S., T. 27, § 35, repealed.** Section 35 of Title 27 of the Revised Statutes is repealed.
