## Chapter 25

### RESOLVE, Providing Moneys for Cerebral Palsy Centers.

**Cerebral Palsy Centers; appropriation. Resolved:** That there is appropriated from the Unappropriated Surplus of the General Fund to the Cerebral Palsy Centers in Maine the sum of \$8,000 for the fiscal year ending June 30, 1972 and the sum of \$8,000 for the fiscal year ending June 30, 1973 to be used to help support a program of home care and day care, purchase of self-help aids and assistive devices, provide extension of therapy, and services of therapists and other professionals; said sum to be allocated as follows: \$2,000 to United Cerebral Palsy of Northeastern Maine, Inc., at Bangor; \$2,000 to Mid-State United Cerebral Palsy, Inc., at Augusta; \$2,000 to Cerebral Palsy Association of Greater Portland, Portland; \$2,000 to Cerebral Palsy Association of Central Aroostook County, Fort Fairfield.

## Chapter 26

### RESOLVE, Providing Funds for Development of Fort Point State Park, Stockton Springs.

**State Park at Fort Point, Stockton Springs; appropriation for. Resolved:** That there is appropriated from the Unappropriated Surplus of the General Fund the sum of \$35,000 for the development and construction of a state park at Fort Point including, but not limited to, access roads, parking, picnic areas and boat dock. Such expenditures shall be expended under the supervision of the Maine State Park and Recreation Commission.

## Chapter 27

### RESOLVE, Relating to an Environmental Study in Construction of High-level Bridge between Westport and Wiscasset.

**Study of construction; authorized. Resolved:** That the Commissioner of Sea and Shore Fisheries is authorized and directed to conduct a study to determine the environmental advantages, if any, or environmental disadvantages, if any, that may be caused by the construction of a high-level bridge between Westport and Wiscasset; and be it further

**Resolved:** That there is appropriated from the Unappropriated Surplus of the General Fund the sum of \$6,000 to carry out the purpose of this resolve.
