Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Appropriation. The following funds are appropriated from the General Fund to carry out the purposes of this Act.

Sec. 2. Lapse of unexpended funds. In the event of settlement of the Indian land claims litigation, the unexpended funds remaining in the All Other account of the appropriation made in section 1 shall lapse to the unappropriated surplus as provided by the Maine Revised Statutes, Title 5, section 1544.

Emergency clause. In view of the emergency cited in the preamble, this Act shall take effect when approved.

CHAPTER 94

H. P. 1845 — L. D. 1950

AN ACT to Authorize Operational Moneys for the Mattawamkeag Wilderness Park.

Be it enacted by the people of the State of Maine, as follows:

Authorization. The Department of Conservation, Bureau of Parks and Recreation shall expend \$20,000 in fiscal year 1980-81 only to assist Penobscot County in the operation and maintenance of the Mattawamkeag Wilderness Park. This expenditure shall be made from funds appropriated in PL 1979, chapter 164 to the Department of Conservation.

CHAPTER 95

H. P. 1985 — L. D. 2018

AN ACT to Establish the Municipal Cost Components for Services to be Rendered in Fiscal Year 1980-81.

Emergency preamble. Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, prompt determination and certification of the municipal cost components in the Unorganized Territory Tax District is necessary to the establishment of a mill rate and the levy of the Unorganized Territory Educational and Services Tax; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

Be it enacted by the People of the State of Maine, as follows:

Municipal cost components for services rendered. In accordance with the Maine Revised Statutes Annotated, Title 36, chapter 115, the Legislature determines that the municipal cost component for services and reimbursements to be rendered in fiscal year 1980-81 is \$6,195,296 broken down according to the following list:

Forest Fire Protection	1,753,478
Land Use Regulation Commission	300,000
Secretary of State	3,000
Property Tax Assessment	259,880
County Reimbursement for Services	1,235,685
Education	2,318,253
Human Services-General Assistance	175,000
