pares and serves food to the public for consumption inside the premises. "Eating establishment" does not include catering establishments, establishments dispensing food solely from vending machines, pushcarts and mobile eating places, roadside stands, retail frozen dairy product establishments or any other such places where customers do not consume food inside the building where the food is prepared and served.

#### §1682. Rest room facilities required

An eating establishment shall provide at least one toilet facility for the use of its customers. The toilets provided shall be clearly marked, maintained in a sanitary condition and in good repair. There shall be no charge for their use. Lavatory facilities shall be located within or immediately adjacent to all toilet rooms or vestibules.

§1683. Rules

The Department of Human Services may adopt, in accordance with the Maine Administrative Procedure Act, Title 5, chapter 375, rules to administer this chapter and thereby protect the public health.

§1684. Enforcement

This chapter shall be enforced by the Division of Health Engineering. Anyone violating this chapter or rules under this chapter commits a civil violation for which a forfeiture of not more than \$200 may be adjudged. Each day of violation shall be considered a separate offense.

Sec. 2. Effective date. This Act shall take effect on January 1, 1987.

#### CHAPTER 172

H.P. 981 - L.D. 1412

AN ACT to Shorten the Final Pay Settlement of Milk Dealers to Producers.

Be it enacted by the People of the State of Maine as follows:

7 MRSA §2954-A, as enacted by PL 1965, c. 449, is repealed and the following enacted in its place:

§2954-A. Payment by dealers to producers

1. First 15 days. On or before the 5th day after the end of the calendar month in which delivery was made, each dealer shall pay each of his producers for milk received from the producer during the first 15 days of that month at a rate that is not less than the most recently published Federal Order No. 1, Zone 21 blend price.

2. Balance due. Each dealer shall make payment to his producers for the balance due for milk received during that month as follows.

A. On or before the 20th day after the end of that month, each dealer shall pay his producers the amount calculated as the initial payment according to the Maine Milk Pool statute, section 3153, subsection 2, paragraph A, and Milk Pool rules, minus the amount of the payment made to the producer under subsection 1.

B. On or before the 5th day after the end of the month in which the payments required by section 1 and paragraph A are made, each dealer shall pay each of his producers any sums received on behalf of his producers pursuant to the Maine Milk Pool statute, section 3153, subsection 4 and Milk Pool rules.

3. Penalties. The license of any dealer who violates this section may be suspended or revoked in accordance with Title 5, chapter 375.

#### **CHAPTER 173**

H.P. 989 - L.D. 1420

AN ACT Requiring the Department of Educational and Cultural Services to Establish Models for Evaluating Teachers.

Be it enacted by the People of the State of Maine as follows:
