CHAPTER 24
H.P. 320 - L.D. 491

**Resolve, Requiring the
Director of the Bureau of Parks
and Lands to Convey Certain
Real Property in the Town of
Richmond**

Preamble. The Constitution of Maine, Article IX, Section 23 requires that real estate held by the State for conservation or recreation purposes may not be reduced or its uses substantially altered except on the vote of 2/3 of all members elected to each House; and

Whereas, certain real estate authorized for conveyance by this resolve is under the designations described in the Maine Revised Statutes, Title 12, section 598-A; and

Whereas, the Director of the Bureau of Parks and Lands within the Department of Agriculture, Conservation and Forestry may sell, lease or exchange lands with the approval of the Legislature in accordance with the Maine Revised Statutes, Title 12, sections 1814, 1837 and 1851; now, therefore, be it

Sec. 1. Director of Bureau of Parks and Lands directed to convey certain land in Town of Richmond. Resolved: That, notwithstanding any provision of law to the contrary, the Director of the Bureau of Parks and Lands within the Department of Agriculture, Conservation and Forestry shall by quitclaim deed and without covenant convey the State's interest in property described in section 2 to Wilhelmine Dennis Oakes or the estate of Wilhelmine Dennis Oakes. Any legal or closing costs of the conveyance may not be paid by the bureau.

Sec. 2. Property interests to be conveyed. Resolved: That the property required to be conveyed pursuant to section 1 is a parcel of land of approximately 7 acres with improvements thereon, located in the Town of Richmond and shown as Lot 67 on Map R6 of the Town of Richmond tax assessor maps.

**Resolve, Regarding Legislative
Review of Chapter 2: Fees for
Muay Thai Contests and
Authorized Participants, a
Major Substantive Rule of the
Combat Sports Authority of
Maine**

Emergency preamble. Whereas, acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, the Maine Revised Statutes, Title 5, chapter 375, subchapter 2-A requires legislative authorization before major substantive agency rules may be finally adopted by the agency; and

Whereas, a major substantive rule has been submitted to the Legislature for review; and

Whereas, immediate enactment of this resolve is necessary to record the Legislature's position on final adoption of the rule; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it

Sec. 1. Adoption. Resolved: That final adoption of Chapter 2: Fees for Muay Thai Contests and Authorized Participants, a provisionally adopted major substantive rule of the Combat Sports Authority of Maine that has been submitted to the Legislature for review pursuant to the Maine Revised Statutes, Title 5, chapter 375, subchapter 2-A, is authorized.

Emergency clause. In view of the emergency cited in the preamble, this legislation takes effect when approved.

Effective May 2, 2025.

CHAPTER 26
H.P. 374 - L.D. 606

**Resolve, to Study Barriers to
Financial Assistance Programs
for Farmers and Food
Producers**

Emergency preamble. Whereas, acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, farmers and food producers are facing increasing challenges when trying to access both state and federal grant programs; and

Whereas, this legislation needs to take effect before the expiration of the 90-day period to allow the Department of Agriculture, Conservation and Forestry, Bureau of Agriculture, Food and Rural Resources to study the bureau's financial assistance programs to identify barriers to and improve effectiveness of these programs as soon as possible; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it

Sec. 1. Commissioner of Agriculture, Conservation and Forestry to seek stakeholder input on lowering barriers to financial assistance programs. Resolved: That the Commissioner of Agriculture, Conservation and Forestry shall direct staff of the Bureau of Agriculture, Food and Rural Resources to study the bureau's financial assistance programs for farmers and food producers to identify barriers to these programs and methods to eliminate those barriers and increase the effectiveness of the programs in addressing farmer and food producer needs. This study must be undertaken within existing resources and must include at least 2 listening sessions with farmers and food producers. The listening sessions must encompass topics, including, but not limited to, the following:

1. Application materials, submission procedures and timelines for application retention by the Department of Agriculture, Conservation and Forestry;
2. Contact procedures to inform applicants of new program opportunities;
3. Accessibility for beginning and emerging farmers and the expansion of education about department programs, partnerships with community organizations to reach new groups of farmers and identification of farmers who currently underuse department programs; and
4. Input on how the department can organize and consolidate its financial assistance offerings.

Sec. 2. Report. Resolved: That, by January 15, 2026, the Commissioner of Agriculture, Conservation and Forestry shall submit a report detailing the results of the study under section 1 and any recommended legislation to the Joint Standing Committee on Agriculture, Conservation and Forestry, which may report out legislation to the Second Regular Session of the 132nd Legislature.

Emergency clause. In view of the emergency cited in the preamble, this legislation takes effect when approved.

Effective May 13, 2025.

Resolve, to Rename a Bridge in Bingham the Barry A. DeLong Bridge

Sec. 1. Bridge in Bingham named. Resolved: That the Department of Transportation shall designate Bridge 2027, which carries Route 201 over Austin Stream in the Town of Bingham and is currently known as the Austin Stream Bridge, the Barry A. DeLong Bridge.

Resolve, to Rename the Twin Rivers Fire Academy in Fairfield the Duane Bickford Fire Training Facility

Sec. 1. Firefighter training facility in Fairfield renamed. Resolved: That the Town of Fairfield shall designate the firefighter training facility in Fairfield, currently known as the Twin Rivers Fire Academy, the Duane Bickford Fire Training Facility.

CHAPTER 29

S.P. 498 - L.D. 1209

Resolve, to Create a Working Group to Study the Safety and Use of Nonconforming Vehicles on Maine's Roads and Highways

Sec. 1. Nonconforming vehicle working group. Resolved: That the Secretary of State shall convene a working group, referred to in this resolve as "the working group," to study the feasibility of allowing registration and use by motorists of vehicles currently prohibited from operation on the State's roads and highways, referred to in this resolve as "nonconforming vehicles," including, but not limited to, mini trucks, antique military vehicles and any other vehicle under 10,000 pounds and operated by a holder of a Class C license, and to review the systems and laws in place for antique vehicles. The working group consists of 7 members as follows:
