### SECRETARY'S REPORT

The summary of the Council's May 5, 1987, meeting was approved and placed on file (Motion by Rep. Diamond; second by Sen. Webster; unanimous).

### Item #1: Approved Step Increases

Norma Larrabee, Law Library Assistant (Salary Range 3), from Step C to Step D, effective May 7, 1987.

#### REPORTS FROM COUNCIL COMMITTEES

# Item #1: Committee on Effective Utilization of Legislative Space

Sen. Pray, Committee Chair summarized the items the Committee had discussed at its recent meeting, and pointed out the interrelatedness of several of the proposals. They include the following:

### 1) Handicapped accessibility to the House Gallery

The Council has already authorized this project. Emphasis now is on identifying alternative ways to provide accessibility, the implications of these alternatives for current space assignments (e.g. press occupancy of Rm. 400 and copying machines in Rm. 401), and the costs associated with each. An architect recommended by Earle Shettleworth, Director of the Historic Preservation Commission, is in the process of developing alternatives.

# 2) <u>Location of all Committee Offices in the State</u> <u>House</u>

Three Committees are still located in the State Office Building, and two committees are currently sharing space. Sen. Pray noted that there are several options available, including reallocation of existing space on the 4th floor and construction of additional offices on the first floor at the south end. Implementation of these would entail options relocating the computer room, and the possible relocation of the Maine-Canadian Office.

### 3) Press Space

The Committee is continuing to explore the feasibility of constructing a facility for use by the State House press. Pursuit of this project may involve relocation of some of the press corps for the Second Regular Session.

### 4) Extending the "mezzanine" level over Room 225

This would provide additional office space required by the Office of Fiscal and Program Review. In discussion Council members expressed concern that this extension be limited to Room 223, leaving Room 221, the Taxation Committee hearing room as is.

# 5) Removing the "inner" stairway between Room 106 and the Library Reading Room

This was approved by the 112th Council, but was deferred until the Library had use of the Liquor Warehouse which is currently being retrofitted as a Central Storage Facility.

No Council Action required.

### Item #2: Personnel Committee

The Committee Chair, Rep. Martin, reported that the Committee had voted unanimously to implement a self-funded income protection plan for legislative employees underwhich eligible employees would receive 2/3 of their salary for up to six months. Application to receive benefits would be made through the Executive Director. All applications would then be reviewed by the Personnel Committee for a final recommendation to the Council. Rep. Martin also noted that Session employees would be eligible during the time of their employment.

Motion: That a self-funded income protection plan be implemented for legislative employees effective as soon as administrative details are in place (Motion by Rep. Martin; second by Sen. Perkins; unanimous).

## Item #3: Committee on Legislative Automation

Rep. Diamond, Committee Chair, reported that the Committee would meet later in the day.

Sec. 8. Black fly control; funds to carry over. Funds appropriated pursuant to Resolve 1985, chapter 41, for the study of black fly control shall carry over and be available for expenditure in the fiscal year ending on June 30, 1988.

Sec. 9. Committee to Study the Retirement System. There is established a committee to study the retirement system which shall consist of 6 members to be appointed as follows: Three members to be appointed jointly by the President of the Senate and the Speaker of the House; and 3 members appointed by the Governor, one of whom shall be designated by the Governor to serve as the committee chairman.

All appointments shall be made no later than 30 days following the effective date of this Act. The

Executive Director of the Legislative Council shall be notified by all appointing authorities once their selections have been finalized.

The first meeting of the committee shall be convened by the chairman of the Legislative Council.

- 1. Compensation. The legislative members of the committee shall receive the legislative per diem rate, as defined in the Maine Revised Statutes, Title 3, section 2. Legislators shall not be paid a per diem when they attend meetings of the committee while the Legislature is in session or in conjunction with serving on another board for which they receive compensation. All members of the committee shall be reimbursed for expenses upon application to the Executive Director of the Legislative Council.
- 2. Duties and responsibilities. The committee shall review all aspects of the Maine State Retirement System, to insure its present and future fiscal soundness, including, but not limited to:
  - A. The present and alternate systems or methods of funding and contributions;
  - B. The present and future investment methods and incomes, including investment management, reporting and policies;
  - C. The present and future expenses and costs of the system, including operating expenses, commissions, salaries and indirect costs;
  - D. The present and future benefit plans and payment methods;
  - E. The anticipated unfunded liability of the system, or other financial obligations that have not been presently met; and
  - F. All other aspects of the laws, operations and procedures of the system that relate to its financial stability and fiscal soundness.
- 3. Staff. The committee may contract for those professionals it requires to assist it. In addition,

the Legislative Council shall provide staff for the committee.

- 4. First meeting. The chairman of the committee to study the retirement system shall call the first meeting of the committee as soon as possible following the effective date of this Act.
- 5. Report. The committee shall report its findings and recommendations, including any implementing legislation, to the joint standing committee of the Legislature having jurisdiction over retirement at the Second Regular Session of the 113th Legislature.
- Sec. 10. Lease-purchase of computer equipment. The Legislature is hereby authorized to enter into purchase or lease with option to purchase or lease purchasing financing agreements for data and word processing equipment with an outright purchase price of not more than \$250,000. The Legislature shall finance the cost of this project with "All Other" funds within their regular budget.

Emergency clause. In view of the emergency cited in the preamble, this Act shall take effect when approved.

Provides funds to allow the task force to contract with outside consultants, specialists or other individuals as required. This appropriation shall carry forward to June 30, 1988.
