

Dear President Pray:

The Joint Standing Committee on Legal Affairs requests permission to retain LD 1377, AN ACT to Clarify the Laws Relating to Notary Public, in committee until the Second Regular Session. The current notary laws contain archaic language which may or may not be obsolete and the laws do not sufficiently address responsibilities, misconduct and the consequences of misconduct.

The same or similar bill has been introduced in the past 2 Legislatures. Each time, the committee to which the bill was assigned - State Government, then Judiciary last session - voted Leave to Withdraw because the issue is so complicated and important and there was not sufficient time to adequately address it.

We would like to investigate the current law and its shortcomings, but realize, once again, that time is too short. We, therefore, request permission to carry-over LD 1377 until the Second Regular Session, at which point we will have more time to devote to a thorough review of the current law and

needed changes. This will also provide ample opportunity for the Maine Bar Association, the Maine Association of Realtors and other interested parties to participate in the review.

Dear President Pray:

The Joint Standing Committee on Legal Affairs requests permission to retain in committee until the Second Regular Session LD 1452, concerning a surcharge on fines to help fund the Maine Criminal Justice Academy. Under current law, municipalities must bear a heavy financial burden when complying with their statutory duty to send their law enforcement officers through training. This bill is intended to help alleviate that problem.

As written, however, the bill leaves several questions unanswered. The committee would like to carry-over the bill to structure an appropriate funding mechanism that will fund the Academy while at the same time reducing the burden on municipalities. This will entail substantial revision of the bill. In addition, we would rather postpone a final decision on this bill until the report of the Academy's review committee is complete, which will be in the next month or so. We will then be able to use the recommendations, as well as our work on law enforcement training (LD 790, approved for carry-over May 19) to present a comprehensive package to the Legislature next session.

We therefore request permission to carry-over LD 1452 until the Second Regular Session.
