MAINE STATE COMPENSATION COMMISSION SPECIAL REPORT MAY 26, 1987

INTRODUCTION

Prior to the lilth Legislature, the specific weekly salaries of the Secretary of the Senate and Clerk of the House and their Assistants were set by statute. In its report to the lilth Legislature the Maine State Compensation Commission recommended that these positions be assigned to pay ranges in the classified state service. The lilth Legislature enacted this recommendation, and the Secretary and Clerk and their Assistants are now assigned to Salary ranges 32 and 24 respectively. The law further specifies that the Legislative Council has the authority to assign the occupants of these positions to specific steps within these ranges.

Succeeding Compensation Commissions have reviewed these salary assignments and found them to be appropriate. However, this Commission was specifically asked by the Legislative Council to review these salaries in the context of the recently adopted classification and pay plans for both non-partisan and leadership staff. This Commission has completed its review of these salary assignments and presents the following findings and recommendations.

FINDINGS

The Secretary of the Senate, Clerk of the House and their Assistants are all assigned to the highest step in their respective salary ranges giving them current annual salaries as follows:

Secretary/Clerk \$41,680. Ass't Secretary/ Ass't Clerk \$30,414.

They were placed in these steps in December, 1985, by action of the Legislative Council.

The Legislative Council unanimously adopted comprehensive classification and salary plans for both the non-partisan staff and staff in the leadership offices in the fall of 1986. These plans provide internal consistency and equity among the legislative offices and among positions having comparable responsibility and authority.

In its review the Commission has related both classification plans, as well as the salary schedules for confidential employees and classified state employees to the offices of Secretary, Clerk, and to those of the two assistants. The Commission also collected information regarding the scope of administrative and supervisory duties and responsibilities of each position. Salaries of the positions were also compared to those of others elected to office by the Legislature.

The Commission's recommendations are designed to balance issues of equity within the Legislative staff and to place the Clerk and Secretary with their peers.

RECOMMENDATIONS

The Commission recommends the following:

1. Effective, July 1, 1987, assign the Secretary of the Senate, the Clerk of the House and their Assistants to salary ranges in the Salary Schedule adopted by the Legislative Council for legislative employees as follows:

Secretary of the Senate/ Clerk of the House: Range 14

Ass't Secretary of the Senate/

Ass't Clerk of the House:

Range 09

The recommended range and step assignments of the Secretary and Clerk within this salary schedule reflect the Commission's conclusion that the scope and level of duties and responsibilities assigned to these two officers are comparable to those of the non-partisan Office Directors.

The Commission recommends that the Assistant Secretary and Assistant Clerk be assigned to Salary Range 09. This salary level is comparable to positions in the legislative plan whose duties require some previous work experience, but are performed under direct supervision.

Proposed legislation to amend 3 MRSA § 162-A to incorporate this recommendation is attached to this report.

2. Assign the incumbents in these positions to steps within the recommended ranges on July 1, 1987, as follows:

Secretary/Clerk:

Step C (\$46,272)

Assistant Secretary/

Assistant Clerk:

Step E (\$31,363)

These increases recognize that the individuals occupying these positions have been "topped out" since December, 1985.

3. The Legislative Council should consider an additional step increase in December, 1987, as follows:

Secretary/Clerk:

Step D (\$48,586)

Assistant Secretary/ Assistant Clerk:

Step F (\$32,932)

This recommendation is designed to re-establish, to the extent possible, a schedule for consideration of annual increases that is consistent with the term of office.

Assign persons newly elected to these positions to Steps A or B of the recommended ranges. Commission members recognize the need for the Legislative Council to have some flexibility to consider a newly-elected individual's prior related experience and salary history. The proposed recommendation for salary at initial appointment is consistent with the statutory provisions for the other state officials elected by the Legislature, with the policies the Legislative Council has adopted for non-partisan and leadership staff.

The result of this recommendation is that the Secretary and the Clerk and their Assistants will not necessarily be in the same steps of their respective ranges in future years. The Commission believes it is essential that the salaries of the incumbents in these positions reflect their actual length of service in the position.

5. Award step increases to the two final steps, or "career steps"; on the legislative salary schedules in a manner consistent with policies already established for non-partisan legislative staff. The ranges in the legislative pay plan consist of nine steps, to provide the starting salary (Step A), six annual increments and two "career" steps, which provide increments to individuals in recognition of their length of service. As with non-partisan employees, movement to these career steps is dependent upon years of service in the particular position and not total legislative service.

Be it enacted by the People of the State of Maine as follows

Sec. 1. 3 MRSA § 162-A, as amended by P.L. 1985, c. 862, § 4, is repealed and the following enacted in its place:

Notwithstanding any other provisions of law, the salaries of the following legislative officials shall be at the salary ranges indicated in this section. At the time of initial appointment the salary of each of these officials shall be set at Step A and, in no case, shall it exceed Step B of their respective ranges. The Legislative Council may adjust the salary of each official by one step for each year of continuous service after the initial appointment of office.

The salary ranges shall be those established by the Legislative Council for legislative staff. No other state salary may be paid to these officials.

1. Range 14: The salaries of the following state officials and employees shall be within Salary range:

Secretary of the Senate; and Clerk of the House of Representatives.

2. Range 9: The salaries of the following State Officials and employees shall be within salary range:

Assistant Secretary of the Senate; and Assistant Clerk of the House of Representatives.

The Joint Standing Committee on Business Legislation requests permission to hold over to the 2nd session of the 113th Legislation LD 1044 "AN ACT to Establish a Voluntary Statewide Building Code and Require Basic Written Contracts for Home Construction work" as amended to be titled "AN ACT to Require Basic Written Contracts for Home Construction Work".

The reason for this holdover request is that on June 2nd a number of technical errors were discovered in this bill by the House Counsel. He has determined that time does not permit remedying these errors in this session and has recommended that the bill be referred back to Committee.

The content of this bill is important to the Attorney Generals' Office and the Committee and, since the Committee has spent considerable time with the bill, the Committee would like to hold the bill over to the next session so that these errors may be corrected.
