Dear Senator Pray:

Last June, the Legislative Council authorized the Joint Standing Committee on Marine Resources to study LD 1328, AN ACT to Establish a Tax to Provide for the Comprehensive Monitoring of Paralytic Shellfish Poison which was held over to the Second Regular Session of the 113th Legislature. The Committee's request for the study provided for a deadline of November 1, 1987 for the Committee's report and January 1, 1988 for submission of legislation.

A subcommittee was established and has held several meetings to consider this important issue. Although there has been agreement on the need for increased resources to address the State's role in paralytic shellfish poison monitoring, as well as federal shellfish sanitation standards, the issue of funding for these needs has taken more time than originally envisioned. Therefore, the Committee requests the Legislative Council to extend the deadline for the Committee's report to December 15, 1987. We see no problem in complying with the original deadline of January 1, 1988 for submission of legislation.

#### Second Draft

#### Memorandum of Understanding

The Maine State Legislature and the University of Maine system hereby agree to establish a State Legislative Internship program for the academic year 1987-88, that will enable students of the University of Maine system to obtain undergraduate credit while participating in a learning-work experience in the House and Senate. In carrying out this understanding the principals agree to the following:

That the University of Maine system will:

- 1. Provide a system-wide program identified as a State Legislature Internship program.
- 2. Provide course credit of 9 degree hours transferable between Units.
- 3. Administer the registration and evaluation of student interms.
- 4. Establish standards for legislative interns and recruit undergraduate students for the program.
- 5. Publicize the program.
- 6. Provide an annual report to the Legislature Council on the program.
- 7. Provide a regular seminar (3 credit hours) to supplement the internship.

The Maine State Legislature agrees to:

- 1. Provide learning-work experiences for the interns as determined by the presiding officers of the House and Senate. It is further agreed that interns may be assigned to offices of both major political parties.
- 2. To prepare a plan for interm assignments.
- 3. Provide reasonable space for them to carry out such duties as they are assigned.

- 4. Provide supervision through the Presiding officers of the Senate and House.
- 5. Reimburse the interns at a rate approved by the Legislative Council.
