You will recall that the Council considered a request from Senator Gauvreau, who chairs the Commission, to apply to NCSL for technical assistance. You tabled the request pending the receipt of additional information regarding cost to the Legislature, etc.

John Selser has sent me the enclosed, and I would point out two things:

- 1. The technical assistance available through this particular project involves development of on-site presentations which have been developed jointly with members and staff of the committee so that the presentation is tailored to the committee's specific interests.
- 2. This project entails no cost to the state.

I think these two points address the concerns you raised at the Council meeting and would recommended that you give Senator Gauvreau and the Commission approval to proceed with NCSL.

Dear Senator Pray:

I have met with David Landes, the project director for the NCSL Cost Containment Project, to discuss details of potential NCSL assistance to the Blue Ribbon Commission on Health Care Expenditures. NCSL is able to provide staff and consultant services to our commission at no cost.

We have discussed scheduling at least two meetings with David Landes for NCSL technical assistance. At the initial meeting, which has been suggested for early January, David Landes would meet with the Commission to discuss current state health care regulatory initiatives, development of an analytic agenda and procedural format. We hope to have a second meeting with him in late spring or early summer. He will be bringing a health care consultant with him at that time as part of the technical assistance project.

NCSL services under this project, including consultation fees, are available without the necessity of a state match. It does appear that it may be necessary to provide air fare for one of Mr. Landes trips; however we will not be asked to pay for any consultant services. Because of the current uncertainty of federal funding for NCSL, Mr. Landes has asked if we would be able to pay for his January trip.

We believe that small cost would be an appropriate use of the Commission's resources and the return on that cost would be substantial. We hope you will approve our request to seek technical assistance from the NCSL Health Care Cost Containment Project, including the minimal use of Commission funds for Mr. Landes' air transportation. Should you approve this request, NCSL requires a letter from the Legislative Council requesting NCSL assistance as a predicate to NCSL involvement with our Commission.

We appreciate your interest in our progress and hope you will approve our request in time to set up a meeting in early January with David Landes. Thank you for your attention to this matter.

This is to inform you that we would like to elevate Larry LaRochelle's status from Legislative Aide (Step C) to Special Assistant (Step A), effective January 7, 1988. On that date, Larry will meet the minimum requirements established by the Council for the position of Special Assistant (two years of on-the-job experience and a four-year degree); in light of his performance on the job and the structure of the classification plan adopted last year, we think it is appropriate that he be reclassified on the abovementioned date.

We also would like some clarification of how the step increases for other employees is to be handled. It is our understanding that a new "anniversary date" of January 1 was established last year for those employees employed when the Council adopted the classification plan last year; others hired after the implementation of the plan would have their actual date of hiring as an anniversary date. Apparently there is some confusion with other offices over this, so we thought it would be appropriate for the Personnel Committee (or the full Council, if you think that's more appropriate) to clarify this before the first of the year.
