Item #1:

Proposed Blue Cross/Blue Shield Rate Increase. (This item had been tabled at the Council's January 6, 1988, meeting pending the Speaker's motion that the Legislative Council file as an intervenor on behalf of the Legislature in Blue Cross-Blue Shield's request to increase rates for non-group subscribers.)

In discussion of his pending motion, Rep. Martin noted that while the Legislature is in a group plan, it is appropriate to file as an intervenor in the current case because history suggests that the final action on the rate for non-group subscribers establishes a strong precedent for action on group plan rates. The hearing on this rate filing is January 12, and, in order to participate as an intervenor, the Council would have to take action before that date. Rep. Martin further noted that the current rate filing proposed a transfer of credits from the group plans to non-group plans and raised questions about the financial implications for various subscribers. He recommended that Jonathan Hull, Legal Counsel to the Speaker, review the entire rate filing, meet with the actuaries and staff in the Bureau of Insurance and the Public Advocate's Office, and come back to the Council with recommendations.

Sen. Perkins asked whether the Council could not simply monitor the hearings rather than become a formal intervenor and leave the formal role to the Public Advocate. Rep. Martin responded that the Public Advocate is technically the representative of the Administration not the Legislature; without separate, formal status, the Legislature would run the risk that its legitimate concerns might not get the same level of response.

The Joint Select Committee on Corrections requests permission to continue its study of corrections issues critical for future planning.

The Committee's interim report will be submitted at the end of February. Although a great deal of progress was made during this interim, there is still much information that needs to be gathered before a long-range plan for corrections can be established.

Maine is currently under consideration for assistance from the Edna McConnell Clark Foundation. If approved, the grant will be channeled through the National Institute for Sentencing Alternatives (NISA), which will provide technical assistance to the Committee and Department. Regardless of the outcome, NISA Director Mark Corrigan has offered his services to the Committee, free of charge.

The Department is in the process of improving its information system. These factors will facilitate the Committee's task, which is a broad and difficult one.

Please find enclosed a draft study proposal. Thank you for taking this request into consideration.

Subject: Study Request

1. COMMITTEE: Joint Select Committee on Corrections

2. SUBJECT OF STUDY:

Continuing to study Corrections issues critical for future planning. Topics include:

- A. Continuing to study the concept of risk management, with assistance from Mark Corrigan, Director of the National Institute of Sentencing Alternatives, taking into account the need for an adequate classification system and a range of placement alternatives that fits the offender population.
- B. Examine the feasibility of treatment capabilities for offenders with special needs. (substance abuse and sex offenders.)
- C. Review the concept of a Community Corrections Act to change the state-local relationship to corrections. This would address the issues of more community-based supervision, punishment/treatment alternatives and incorporating county jails into the state system.
- D. Review sentencing options in other states and examine feasibility of such options in Maine.
 - E. Continued study of housing options in Corrections.

3. COMPLETION DATE:

The Committee would like to hold 12 meetings between May and November. A final report will be submitted by December 31. 1988.

4. ANALYSIS OF THE PROBLEM:

As stated in the Committee's first report to the Legislature in 1987, the primary goal of corrections is public protection, which is best accomplished through a system of risk management. The conditions at Maine's correctional facilities remain critical, and there is a continued need for executive, legislative and judicial branches of government to work together to develop methods and strategies for successful handling of corrections problems and resources in the future.

5. REASON FOR THE STUDY:

In the past, one of the major difficulties confronting the Committee in its task has been a lack of complete data on Maine's offender population, the narrow range of corrections strategies available, and an incomplete understanding of the many factors affecting risk and classification.

During the interim, the Committee worked with Department officials to obtain information necessary to understand issues relating to risk needs assessment and management. Assistance was provided by Mark Corrigan, who is an expert in the field.

A report will be submitted at the end of February, which includes recommendations concerning probation management, pre-sentencing investigation, program improvements, and options for Maine State Prison.

However, although a great deal of information was provided to the Committee, there is still a need to obtain further information and develop a thorough understanding of such issues as: the nature of the offender population, state-of-the-art risk assessment methods, alternative corrections strategies, and treatment strategies for offenders with special needs.

The Department is in the process of computerizing its offender population, which will make information more easily available in the future. Mark Corrigan has also offered to provide his services, free of charge.

Continued careful, deliberate study is needed to avoid bad planning and enable the Committee to provide a feasible long-range plan for corrections.

6. STAFF SUPPORT:

Up to this time, staff support for the study of Long Term Planning for the Corrections System in Maine has been provided by contract (half-time) with Annika Lane. This support has been indispensable, and the Committee proposes to continue that contract until December 31, 1988.

STATE OF MAINE

In Senate December 3, 1986

Ordered, the House concurring, that a Joint Select Committee on Corrections shall be established. The select committee shall consist of 3 members from the Senate, to be appointed by the President of the Senate, and 10 members from the House of Representatives to be appointed by the Speaker of the House. The select committee shall review all legislation relating to corrections and report its findings and recommendations to the Legislature.

Dear President Pray:

The Blue Ribbon Commission to Study the Regulation of Health Care Expenditures has made considerable progress in its efforts to accomplish its task. We are at a crucial stage in our work involving an in depth analysis of issues and policy options concerning the delivery of health care in Maine to ensure reasonable access for Maine citizens to quality health care at an affordable cost.

The Office of Policy and Legal Analysis has provided excellent staff support for this Commission through the services of John R. Selser and Annika Lane. However, Mr. Selser will be devoting most of his time during the legislative session to his regular committee assignment and business associated with the legislative session. Ms. Lane is operating under a contract with the Legislative Council which expires Feburary 28th.

If the Blue Ribbon Commission is to complete its task prior to the reporting deadline of January 15, 1989, we will need additional staff assistance. Accordingly, we request authority to hire Annika Lane, on a contract basis, through December 1988. Her excellent working relationship with the Commission has been a valuable asset to this study. We wish to dedicate \$13,000 of the Commission's funds to contract for half of Ms. Lane's time to staff the Commission, in coordination with the Office of Policy and Legal Analysis, through December 31, 1988.

The Commission will also be using the services of an expert health care consultant. As the study progresses and as we define in more detail the assistance we will need from the health care consultant, we will be contacting you with more details of our request for second year funding.

The membership of the Commission is unanimous in its support of the action requested in this letter. We hope you will act favorably on this request at your earliest convenience to avoid any disruption in Commission staffing. Thank you for your consideration.

Dear Chairman Pray:

Resolves 1987 chapter 39 requires that the Commission on Sport Fishing report to the Legislature on February 15, 1988.

The Commission has not yet completed its work and has submitted to the Revisor of Statutes the enclosed request for an extension until Dec. 1, 1988.

The reasons that the Commission's work has not been completed are:

- 1. The Commission has determined that the subject of sport fishing management is very extensive and time consuming. Encompassing, among other things, the carrying capacity of Maine's waters, angler desires, current hatchery capacity, state of the art hatcheries and hatchery financing.
- 2. Certain parts of the Commission's assignment will require expert testimony from out of state professionals. Time is required to identify these individuals, arrange for financing their appearance and to schedule their appearance.
- 3. The Commission to Study the Impact of Game and Nongame Species on Maine's Economy is to cover many areas that will assist our Commission and, in all likelihood, support its findings. This Commission will be receiving quarterly reports during 1988 and a formal interim report on December 1, 1988.

The Commission's work schedule is to complete its testimony and research by September 30, 1988, and as indicated on the previous page, to report to the Legislature no later than December 1, 1988.

The Commission is submitting this letter to keep you and the Council apprised of the status of this project. I would be pleased to respond to any questions that you may have.
