ANNUAL REPORT MAINE HIGH RISK INSURANCE ORGANIZATION FEBRUARY 29, 1988

The Maine High Risk Insurance Organization was created by the Legislature in 1987 to provide health insurance to persons who are otherwise unable to obtain coverage for medical reasons. On August 26, 1987, Governor John McKernan appointed the following individuals to the Board of Directors:

The Board of Directors have met on the following dates:

October 14, 1987 November 2, 1987 December 9, 1987 January 13, 1988 February 10, 1988

Subcommittees for Finance and Administration, Insurance Plan Design, Request for Proposal, and Public Awareness have been established.

The Board is developing the plans for the implementation of a high risk insurance plan by July 1, 1988. While we have made significant progress to date, much work remains to be done to bring this plan on line before the deadline and to administer the plan fairly.

A Request for Proposal has been developed by the Board and submitted to approximately twenty insurers to provide administering insurer services. It is anticipated that responses will be received by March 1,1988. Once this organization is selected, the Board will rely heavily on them for detail support of the high risk insurance pool, such as plan design, public awareness, premium and insurance plan administration, etc.

The Board has several concerns as detailed below:

- 1. Financing. The amount of resources may be inadequate to provide the necessary reserves to insure up to 300 high-risk individuals. Although revenues are capped both from premium income and hospital assessments, the amount of claims are unknown. This may create a significant financial problem.
- 2. <u>Staff Support</u>. There is a lack of provision for staff support in this legislation. We believe staff support is necessary to accomplish our objectives.

- 3. 300 limit. We are concerned that this program is limited, potentially reaching only 300 individuals. The Board feels this number will be met quickly, thus excluding many individuals needing health insurance. This program targets primarily middle to upper income individuals, and it does not provide access to insurance for the working poor who may not be covered by other governmental programs.
- 4. Hospital Assessment. The hospital assessment issue is one that requires careful consideration by the Board and the Legislature. Some members consider it a tax on hospitals and on those who pay for care, and believe the assessment should be broader based in terms of taxing individuals through general revenues. This issue becomes even more significant when one considers the current Medicare freeze and the resulting disproportionate share paid by other payors of healthcare.

The Board, through submission of an operating budget to the leadership of the House and Senate, has requested the Legislature to approve the maximum allowable assessment to hospitals for the first year. This amount will be needed to cover the claims for the 300 insured individuals.

The Board members of the Maine High Risk Insurance Organization continue to work toward accomplishing its objectives in a short timeframe. With the cooperation of the Legislature, we look forward to providing a much-needed service to those who cannot obtain health insurance because of medical reasons. Since this is a demonstration project, we expect to make specific recommendations to the Legislature next year.

As required by 20-A MRSA §11113, members of the Joint Standing Committee on Education have reviewed the application for legislative review of certain Maine State Museum rules. This letter is to notify you that more than 1/3 of the full committee has determined that the public interest would be served by review of the rules in question and the Committee is prepared to go forward with a review.

As you are aware, 20-A MRSA §11112 requires an application for legislative review of rules to be submitted on behalf of 100 or more "registered voters." The application in question has 130 signatures. However, members of the Committee have no independent way of verifying whether these are signatures of registered voters. Therefore, we recommend that you, in conjunction with our committee staff and the Secretary of State's Office, begin immediately to work out a process to verify that at least 100 of the signatures are of registered voters. If the signatures are found to be valid, the Committee will schedule a public hearing on the rule.

Finally, the Committee believes the rules review law is unclear as to who bears the responsibility for verifying that signatures on an application are of registered voters. We understand that a bill, LD 1651, currently before the Joint Standing Committee on State and Local Government, could serve as a vehicle to clarify that point. We recommend that the Committee be informed of this concern and encouraged to take appropriate action.
