RE: Council Policy and Procedures  
Relating to After Deadline Requests

1. There is cause for concern over the small numbers of bills that have been printed to date in this Session. As of today we have only 52 bills printed. In the 113th we had 154 L.D.'s printed by January 31, 1987, and 373 L.D.'s by February 15, 1987. In the 112th we have 335 L.D.'s by January 31, 1985 and 583 L.D.'s by February 15, 1985.
2. Experience suggests that the later bills are printed, the less time to consider them wisely. The more bills that are printed, the longer time the session requires.
3. Therefore, I recommend we establish an After Deadline Request Table. All bills received after today shall be placed on this table until such time as we have printed all bills filed before cloture. Then each bill shall be dealt with individually by the Council in the usual manner.
