The letter from Rep. Mayo and Commissioner Mattimore reported that the Committee appointed by the Council Chair to review the proposals was unanimous in recommending that the Council award the contract to Peat Marwick Main & Co.

Motion: That the Council approve the recommendation to award a contract to Peat Marwick Main & Co. for the purpose of conducting a Tax Revenue Study with a preliminary report to be submitted no later than May 5, 1989, and a final report no later than May 12, 1989; for a total amount of \$83,000 for fees and up to \$8,300 for reimbursement of expenses related to the study; and, further, that the Contractor be informed that the analysis of the corporate income tax and any related recommendations is not required to be completed within the May 5/May 12 time frame, but may be completed subsequent to those deadlines. (Motion by Sen. Pray; second by Sen. Dutremble; unanimous).

Motion: That the Executive Director be authorized to notify the Chairs of the Committee on Appropriations & Financial Affairs of the Council's action and to request that the Committee take the necessary steps to appropriate \$91,300 to the Legislature's Fiscal Year 1989 budget. (Motion by Sen. Pray; second by Rep. Mayo; unanimous).



Dear Charlie:

Prior to the meeting of the AMHI Oversight Committee on April 6th at 3:00 p.m. legislators represented on the AMHI subcommittee met with Speaker Martin at his office to discuss leadership of the subcommittee. The Speaker recommended that the committee select amongst its membership a legislator to serve as the subcommittee Chair. Accordingly, during the AMHI Oversight Committee meeting which followed I was selected to serve as Chair of the committee. It was also decided that the legislators in the committee would meet to determine whether a co-chair or vice-chair should be selected as well.

I raised the issue of whether the committee should continue to rely upon staff supplied by the Department of Mental Health and Retardation in its deliberations. It was agreed by all committee members that the committee should be served by independent staff. It would be my recommendation that non-partisan staff of the Office of Legal Policy and Analysis be provided to the committee to serve it for the balance of its deliberations.

There is a distinct possibility that the Oversight Committee will remain beyond the length of this year's legislative session. It is reasonable to assume that a 12 to 18 month period of time will be required in which to implement any recommendations which flow from the committee. I believe this matter should be brought to the attention of the Legislative Council at its next scheduled meeting. I would be pleased to meet with you and discuss your thoughts in regard to this matter.

Dear John,

Per our conversation, we, the Chairs of the Audit and Program Review Committee, are formally requesting that the Legislative Council allow our Committee to recommence our review of the Child Protection System in the Department of Human Services.

As you may remember, our work on this difficult and complex matter was interrupted last year, just as we were about to embark on the most critical phase of our effort - redesigning the system, after an often agonizing study of almost three years. We agreed, at your suggestion, that we hold off further activity until the Ombudsman that we recommended was in place.

We perhaps did not realize that this would take so long. But the Ombudsman is now functioning and we have had several discussions with her and believe that she will be a most valuable resource to any redesigning that is done.

Several bills before the 114th and recent press attention have made it clear that the present system still has significant flaws. We are also concerned that the Human Services Department has stated publicly that our Committee has given them a clean bill of health. Nothing is further from the truth.

We hope that the Council will allow us to proceed.
