SECRETARY'S REPORT

The summary of the May 9, 1989, Council meeting was accepted and placed on file. (Motion by Sen. Pray; second by Rep. Marsano; unanimous).

EXECUTIVE DIRECTOR'S REPORT

Sally Diamond, Executive Director, presented the following items for the Council's consideration:

Item #1: Approved Step Increases

Ms. Diamond reported that she had approved the following step increases, based on the favorable recommendation of their Office Director, Bent Schlosser:

James Clair, Principal Analyst, Office of Fiscal and Program Review, (Salary Range 12), from Step C to Step D, effective May 20, 1989.

Cheryl Ring, Principal Analyst, Office of Fiscal and Program Review, (Salary Range 12), from Step D to Step E, effective May 20, 1989.

Item #2: Step Increases Requiring Consideration by Personnel Committee

Ms. Diamond reported that both Bent Schlosser, Director of the Office of Fiscal and Program Review, and Lynn Randall, State Law Librarian, have anniversary dates in the month of June and are thus eligible for consideration of step increases. It is established Council policy that the Personnel Committee participate in the annual review of those assigned to Salary Range 14.

Motion: That these step increases be referred to the Personnel Committee for review and a report to the full Council. (Motion by Sen. Pray; second by Sen. Clark; unanimous).

REPORTS FROM COUNCIL COMMITTEES

Personnel Committee

Sen. Clark, Committee Chair, reported that the Committee had met to consider the item re-referred to it at the May 9 Council meeting - overtime pay for House and Senate staff. She reported that the Committee's discussion had resulted in a unanimous endorsement of its initial recommendation and presented a motion to that end.

Motion: That the Legislative Council authorize paid overtime to House and Senate staff once they have exceeded the established ceilings for the accrual of compensatory time; and, further, that this policy extend only to adjournment of the First Regular Session <u>sine die</u>. (Motion by Sen. Clark; second by Rep. Marsano). Discussion focussed on the following issues:

- Whether the policy would be restricted to a) staff in Salary Range 6 or below (i.e. clerical staff), and
 b) particular House and Senate offices (Speaker Martin).
- Whether traditional differences in the services provided by staff to members in each body (e.g. weekly mailings) justified a difference in policies related to overtime (Sen. Clark).

EXECUTIVE SESSION

Motion: That the Council go into Executive Session for the purpose of discussing matters related to personnel. (Motion by Sen. Pray; second by Rep. Marsano; unanimous)

The Council thus went into Executive Session at 4:25 p.m.

RECONVENE

The Council was reconvened by the Chair, Speaker Martin, at 4:56 p.m.

Motion: That the Council approve an amendment to Sen. Clark's original motion that paid overtime would be available only to secretarial staff in the Offices of the Clerk and Secretary and the leadership offices, thus excluding Chamber staff. (Motion by Sen. Webster; second by Rep. Wester; approved 8-1).

The Chair then asked for a vote on Sen. Clark's original motion with this amendment. The motion was approved 8-1.

Committee on Legislative Automation

Rep. Mayo, Committee Chair, reported that the Committee had met and had been given a complete tour of the Legislature's computer facilities by John Bailey, Information Systems Director. He noted that the Committee had also begun a discussion of the future direction of automation in the Legislature and would be developing some recommendations for Council consideration at a later date. Finally, Rep. Mayo noted that the Committee had discussed the current procedures and tools available to handle power interruptions, but had no specific recommendation at this time.

No Council action required.

OLD BUSINESS

Item #1: Interim Studies (Tabled at May 9 Council Meeting)

Speaker Martin briefly described the types of interim study requests that the Council would be considering before adjournment <u>sine</u> <u>die</u>. These include:

A. Statutory Study Commissions

These studies are proposed in legislation. Once accepted by both houses, the bills are generally referred to the Appropriations Table, where they sit until the Table is cleared during the final days of the session. In recent years, the Appropriations Committee has essentially turned the study bills over to the Council, along with a "budget". The Council schedules a special meeting to consider these; and the Appropriations Committee has accepted its recommendations.

B. Council-Approved Interim Studies

The Council has operated under procedures for several years that provide an opportunity for Joint Standing Committees to submit requests by letter to study a particular issue. Generally, these proposed studies are related to legislation the Committee has been dealing with or with an issue it knows it will be addressing in the coming session.

The Council considers these requests at a single meeting, and the recommendation to approve includes: a) Topic and scope of study; b) size of study committee (generally 5 - all legislators); and c) number of meetings.

NEW BUSINESS

Item #1: Request for Amendment to Contract with Peat Marwick Main & Co. to Review the State's Individual Income Tax Withholding Tables. (Letter from Rep. Cashman and Proposal from Peat Marwick)

Motion: That the contract with Peat Marwick & Main be amended to authorize expenditure of up to \$5,000 above the original contract amount for the purpose of conducting an analysis of the individual income tax withholding tables currently in use and recommendations for revising these. (Motion by Sen. Pray; second by Sen. Dutremble; unanimous).

Item #2: Joint Standing Committee on Audit and Program Review: Submission of Draft Reports.

Copies of these draft reports had been distributed to Council members previously.

Motion: That the reports be accepted and placed on file. (Motion by Sen. Clark; second by Sen. Webster; unanimous).

Item #3: Repair of State House Roof. (Letter from Earle Shettleworth, Chair, State Capitol Commission)

A letter from Earle Shettleworth, Chair of the State Capitol Commission, reported that the Commission had pursued both architectural and engineering studies of the roof of the West Wing of the State House, which had experienced severe leakage during the summer of 1988. Mr. Shettleworth requested the Council's support of the Commission's request to the Appropriations Committee for funds to replace the existing roof and to complete the necessary structural work to support the new roof. The preliminary estimate for this work is \$99,125. Ms. Diamond, who sits as a nonvoting member of the State Capitol ex officio, observed that tests results for asbestos in the existing roof had been positive, but that no estimate was available yet for the removal of the contaminated material.

Motion: That Ms. Diamond forward the Commission's request to the Joint Standing Committee on Appropriations and Financial Affairs with a cover letter from the Council Chair indicating the Council's unanimous support of the request. (Motion by Sen. Clark; second by Rep. Marsano; unanimous).

Item #4: After Deadline Requests

After deadline requests were considered by the Legislative Council. The Council's action on these requests is included on the attached list.

Item #5: Requests to Carry Bills Over to the Second Regular Session

A list of the requests considered by the Council with the Council's action noted is attached.

ANNOUNCEMENTS AND REMARKS

Rep. Webster inquired about the status of the study of legislative operations which has been enacted and signed by the Governor (Chapter 15 Resolves, 1989).

Motion: That the Legislative Council authorize introduction of legislation which would change the date by which a contract was to be awarded, provided that this date was no later than July 15. (Motion by Sen. Pray). The Chair then polled the Council members individually in accordance with Council procedures for After Deadline Requests. The bill was unanimously approved.

ADJOURNMENT

The Council meeting was adjourned by the Chair at 5:32 p.m.

RE: Agency Requests for Statute Text Prints

DATE: June 8, 1989

1. BACKGROUND

As you know, the Revisor's Office and the Office of Legislative Information Systems cooperatively support a computerized database which contains the full text of the Maine Revised Statutes. This database is primarily used to draft proposed legislation and to ensure proper maintenance of the Maine Revised Statutes Annotated.

This office has customarily provided State departments and agencies with full text prints of these portions of the statutes which apply to their areas of authority. We now have 23 requests for "statute prints" pending as we have not been producing these requests during last summer's system conversion from IBM to Wang, and while the legislature has been in session.

We expect the number of these requests to significantly increase once the First Regular Session ends, as agencies will want current editions of "their" laws, both for internal use and for publication.

2. PENDING ISSUES

Two issues relating to these requests require your review. First, we have not charged any fee for provision of this service, and you may wish to begin to recover a portion of the marginal costs we incur. Second, some requestors have come to see the Revisor's Office as a typesetting and composing service rather than an information source. We propose to provide the information in one uniform manner, and let the agencies edit or format it as each may wish.

3. RECOMMENDATIONS

I recommend the Council adopt the following policies:

- A. Provision of "statute prints" to departments and agencies is an authorized function of the Revisor's Office. However, it is a secondary function to support of the Legislature, and should be deferred until the workload of the Legislature permits this production.
- B. These requests will be filled by the provision of the unedited text of a statute or range of statutes by one printed out copy and on computer disk. Agencies may use the computer disk to transfer the information to their own word processing equipment, and edit it as they wish.
- C. The agency will be charged a fee of \$50.00 per request, plus \$1.00 per printed page of text.

The resulting cost to an agency (generally between \$100 to \$500 per request) will not be so much as to discourage distribution of this information, but should be enough to deter frivolous or poorly thought out requests. Such a fee will in no way cover even a small portion of the costs of maintaining our statutory database, but is estimated to cover our direct costs incurred in filling these requests.

Please note that these recommendations do not address external requests for the provision of information, and I propose to continue to defer those requests until the Council has an opportunity to consider that issue in the broader context of a public information and pricing policy for a number of items.

I would be happy to answer any questions you may have concerning these proposals. Thank you.

STATE OF MAINE 114TH LEGISLATURE FIRST REGULAR SESSION

COMMITTEE AMENDMENT "." to H.P. 1172, L.D. 1626, Bill, Resolve, Concerning the Development of a New Master Plan for the Capitol Area.

Amend the resolve by striking everything immediately after the title and inserting in place thereof, the following:

Emergency preamble. Whereas, Acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, a new master plan is urgently needed to guide future development of the capitol area which is held in trust for the people of Maine; and

Whereas, this plan must serve as a blueprint for the future, recognizing reasonable growth with a commitment to protect and preserve our valued inheritance; and

Whereas, the district plan requires active participation from the highest levels of the city government and each of the 3 coequal branches of State Government to inspire the best usage and appreciation; and

Whereas, it is desired to select a master planner through a competitive search; and

Whereas, an ad hoc committee is necessary to oversee the selection of the master planner and the development of the first new master plan for the capitol area in 20 years; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

Committee established. Resolved: That there is established the Ad hoc Committee on the New Capitol Area Master Plan; and be it further

Master plan; development. Resolved: That work on the development of a new master plan for the orderly development of future state buildings, grounds and traffic routes in the capitol are of Augusta shall be initiated as soon as possible after the passage of this resolve. A nationally recognized master planner shall be selected and engaged, and this planner shall be required to have a master plan available in sufficient time to be included in legislation presented to the First Regular Session of the 115th Legislature; and be it further

Selection of master planner. Resolved: That selection of the planning consultant shall be made by means of a competitive search with no geographic limitation as to entrants. The selection of the planning consultant shall be approved by the Ad hoc Committee on the New Capitol Area Master Plan; and be it further

Membership; appointment. Resolved: That the Ad hoc Committee shall consist of the following 23 members.

- 1. The 3 Representatives and the Senator who represent the City of August in the Maine Legislature;
- 2. The chairperson of the Augusta Planning Board or the chairperson's designee;
- 3. The chairperson of the Augusta Zoning Board of Appeals or the chairperson's designee;
- 4. The director of the Augusta Public Works Department or the director's designee;
- 5. Four residents of the City of Augusta who are not employed in State Government, appointed by the Mayor of Augusta;
- 6. The City Councilor of Augusta representing the citizens residing in the Capitol Planning District area;
- 7. The Director of the Bureau of Public Improvements or the director's designee;
- 8. The Commissioner of the Maine Department of Transportation or the Commissioner's designee;
- 9. The Director of the State Planning Office or the director's designee;
- 10. The Executive Director of the Historic Preservation Commission;
- 11. The Director of the State House and Capitol Park Commission;
 - 12. The chairperson of the Capitol Planning Commission;

- 13. The chairperson of the Supreme Judicial Court Plan and Design Commission or the chairperson's designee;
 - One member appointed by the Governor;
- DRAFT 15. One member appointed by the Speaker of the House of Representatives;

- The director of the Kennebec Valley Chamber of 17. Commerce or the director's designee; and be it further

Chair. Resolved: That the Chair of the Capitol Planning Commission shall serve as chair of the Ad hoc Committee and shall call the first meeting of the committee as soon as all appointments have been made. The chair shall call all subsequent meetings of the Ad hoc Committee; and be it further

Duties of the Ad hoc Committee. Resolved: That the duties of the Ad hoc Committee shall be as follows:

- 1. Oversee the competition for selection of a master planner who will develop a proposed new capitol area master plan and participate in all aspects of the selection process, including review of criteria for selection, screening and final selection of candidates for this role;
- 2. Participate actively in all phases of the development of the new master plan, and ensure coordination of this effort with other concurrent planning efforts within the capitol area;
- Present to the Capitol Planning Commission at times specified by the commission an interim report and a final report. The final report shall contain the new proposed master plan for the capitol district, recommendations regarding implementation of the plan and recommendations for any necessary implementing legislation; and be it further

Report. Resolved: That, in addition to other reports required in this section, the Ad hoc Committee shall report to the Governor and the Legislative Council at the completion of each stage of the development of the master plan; and be it further

Commission report. Resolved: That, the Capitol Planning Commission shall present an interim report no later than February 1, 1990 to the joint standing committee of the Legislature having jurisdiction over State government matters. The interim report shall describe the progress of the Ad hoc Committee and any recommendations proposed by the Ad hoc The commission shall submit a final report to the Committee. Legislature no later than January 15, 1991. The final report shall include a new master plan for the Capitol Planning District and any necessary implementing legislation; and be further

Staff. Resolved: That, the Ad hoc Committee shall be authorized to hire staff, who shall work under the direction of the chair. Additional assistance from the legislative staff may be requested from the Legislative Council; and be it further

Compensation. Resolved: That all members of the Ad hoc Committee, except the employees of State Government, shall receive reimbursement for travel and other necessary expenses upon application to the Executive Director of the Legislative Council. Members of the Ad hoc Committee who are Legislators shall receive the legislative per diem as defined in the Maine Revised Statutes, Title 3, section 2, for each day's attendance at committee meetings; and be it further

Appropriation. Resolved: That the following funds are appropriated from the General Fund to carry out the purposes of this resolve.



The Capitol Planning Commission will submit a new master plan for the Capitol Planning District by January 15, 1991 to the 115th Legislature. The purpose of this resolve is to ensure that haphazard development around the State House and other important state facilities is prevented.

Dear Senator Pray:

I am writing to you in the hope that you can solve what I perceive: to be a very serious problem.

I suffer from Spinal Muscular Atrophy, one of the diseases known as Muscular Dystrophy. I have a handicapped plate because of the fact that I am unable to walk long distances without a great deal of difficulty.

I attended a legislative hearing a short time ago and found that the number of handicapped parking spaces were few and far between and they were all occupied at the time that I arrived. I observed, however, that there were many spaces available for members of staff and the press, and those reserved spaces were located in a location that would be the more logical sites for handicapped parking.

Until one has a problem such as mine, concerns about parking, walking, or just doing those daily chores that you take for granted don't have much significance. However, once a disease like this hits you, you take a long hard look at these issues.

With issues involving the handicapped and elderly coming to your desk on an ever increasing basis, the need for handicapped spots will be on the increase also. Anything that you can do to address this situation would be greatly appreciated.

Dear Ms. Diamond;

It appears that your office may hold the key to resolving a problem recurring over the past few years. The harried Committee Chairmen of Standing Committees have unnecessarily borne the brunt of the public's frustration with:

- 1) the inabilty to enter the crowded hearing room
- 2) the frustrating moves from room to room with seats lost
- 3) the crowding back along the walls (providing fire aisle)
- 4) lack of provision for overflow hearing the proceedings
- 5) and faulty PA systems within the hearing rooms + lack of air

While we are in sympathy with the need to work within a budget other standby arrangements are clearly needed. Could there be a standing arrangement with The Augusta Civic Center or the August Armory or the University of Maine at Augusta to have a <u>large</u> room reserved for possible extra large hearings M-F during the usual hearing weeks?

It is clearly not within the purview of Committee Chairmen to estimate the number of attendees on particularly sensitive issues. A standby policy such as above would relieve them of such unwarranted and unpleasant pressures. Please try to find a solution removing a barrier to a happier relationship for the people of Maine with their elected representatives.

Another problem for Maine citizens exercising responsible citizenship is that of finding parking spaces within easy walking distance of the hearing rooms. In recent years the spaces for citizen parking have been assigned to legislators and state employees. Those people remain there for a number of hours. Another parking area at a distance from the state house could be provided with a shuttle bus running at regular intervals. The icy conditions this winter made a walk from the furthermost parking spaces open to the public really hazardous especially for senior citizens. Would this be a problem the Legislative Council could also solve? I assure you it would be greatly appreciated.

- 2. "Executive Director" means the Executive Director of the Legislative Council.
- 3. "Legislative Council" means the Legislative Council as established in the Maine Revised Statutes, Title 3, section 161.
- 4. "Legislative staff" means the nonpartisan legislative staff offices of the Legislature, including the Office of the Executive Director, and the partisan legislative staff offices; and be it further

Advisory committee established; membership. Resolved: That the Advisory Committee on Legislative Structure and Operation is established to monitor and facilitate a study of the structure and operation of the Legislature. For the purpose of this resolve, "advisory committee" means the Advisory Committee on Legislative Structure and Operation.

- 1. The advisory committee shall consist of 8 members appointed as follows:
 - A. Four members appointed jointly by the Speaker of the House of Representatives and the President of the Senate. Two of the 4 members shall be members of the 114th Legislature and 2 members may not be Legislators; and
 - B. Four members appointed jointly by the Speaker of the House of Representatives and the President of the Senate, upon the recommendations of the minority leader of the House of Representatives and the minority leader of the Senate. Two of the 4 members shall be members of the 114th Legislature and 2 members may not be Legislators.

The 8-member advisory committee shall be appointed within 30 days following the effective date of this resolve.

- 2. There shall be 2 chairs of the advisory committee who shall be selected by the Legislative Council from among the members of the advisory committee. The 2 chairs shall be subject to unanimous approval by the Legislative Council.
 - 3. The advisory committee shall:
 - A. Review and make recommendations with respect to the request for proposals developed by the Executive Director;
