Dear Governor and Members of the Legislative Council:

This letter is written to you pursuant to Section 7 of Chapter 60 of the Resolves of the State of Maine which governs the development of a new Master Plan for the area of the Maine State Capitol. As you may recall, I am the Chairman of the Special Committee established by the Resolve, and among my duties are a series of reports to you. The initial report was to have been made by January 1, 1990 and is being made approximately four weeks late so I could give you the status of the activities of the Special Committee after our recent meeting of January 22, 1990.

As you know, the Committee is primarily instructed to find, and then supervise, a "Master Planner" for the Capitol area who is to be "nationally recognized" and is to develop a Master Plan for submission to the Legislature and the Governor.

In order to help us do an adequate job, since none of us is an urban planner, our Committee employed an experienced urban planner to assist us in defining our mission and locating our planner. Upon the advice of the planner, and after several meetings, invitations were sent to 22 nationally recognized urban design firms to submit their qualifications. The invitations went out in late December and the responses were virtually all received by our meeting of January 22. Approximately 12 firms sent in complete qualification data, and we have elected to interview 6 of the firms as finalists. Several of the applicants have either associated themselves with Maine firms or have an office in Maine. Each of the finalists appears amply qualified to fulfill the mandate of the legislation. The interviewing will take place during the first week of March, and pursuant to the legislation, we will endeavor to submit a work plan for completion of the Master Plan to the Governor and the Legislature by the first of April.

I might note that several of the firms who did not apply, as well as several of the firms who did apply, noted that a quality Master Plan could not be accomplished for the appropriated sum of \$90,000. Several experienced planners, including the consultant to the Special Committee, have indicated that the scope of the Legislation is such that the probable cost for this project will be more likely to total several times the appropriation if not a bit more. Accordingly, I would welcome the opportunity (and have been requested by the members of the Special Committee) to discuss the fiscal basis for this project with the Legislative Council and/or the Office of the Governor at your earliest opportunity.

I think it is fair to say that there has been interest and enthusiasm on the part of most of the members on the Committee for this project; we are, however, worried about our ability to produce a competent Master Plan without the resources which apparently will be required for this undertaking. The prospect of the new Supreme Court facility in our "neighborhood", the competition for scarce space in the area of the Capitol, the controversy about the State and Augusta parks, traffic planning, and the many other issues confronting government in Augusta would seem to compel consideration of the investment of the funds necessary to assure excellence in the planning process.

I look forward to meeting with the appropriate persons to discuss the status of this project.

Dear Mr. Oxman:

I am writing on behalf of the entire Legislative Council to acknowledge receipt of your letter regarding the need for additional funds to support the Commission's work in the coming year.

As you know, the Legislative Council was instrumental in introducing the legislation that mandated the development of a new master plan for the Capitol Area and for establishing the Special Commission to oversee, this important project. The Council unanimous support for this undertaking remains strong. It is long overdue. We recognize, further, that we are at an important juncture in terms of development in the City of Augusta and that it is imperative to have a master plan to provide the framework for informing this development. Discussions underway, for example, concerning the development of a third bridge, the disposition of the railroad right-of-way, and the disposition of the City-owned portion of Capitol Park would all have long term impact on the character of the Capitol Area District.

Unfortunately, the State's current financial situation precludes us from demonstrating our continued and strong support for the development of the Master Plan. The Legislature is in the process of reviewing all state agency budgets, and I think it is safe to say that none will go untouched. We have agreed to protect the funds currently available to the Commission for contracting with an experienced master planner. We cannot, however, advocate the appropriation of additional funds at this time given, the financial picture.
