

Earlier in this session the three committees involved in this issue held a joint session to give all members the opportunity to review findings of the MML Study with staff from PHR. Additional bills have also been introduced during the current Legislative Session in part as a result of the findings of Medical Malpractice Liability Study.

We are now at a point where these bills must be forwarded to the full Legislature. Yet we, on the Judiciary Committee at least, are still in need of some additional expertise on these matters from PHR. It is for this reason that I am requesting that the Council allocate up to \$2,000 to cover the cost of consulting time and travel from PHR. This will include an update on recent findings from other states, answering questions generated by the three committees on both malpractice insurance and tort issues, presenting technical information to the Banking and Insurance Committee on LD 2389 and, if time permits, meeting with members of the Committees again to review proposed revisions to the bills.

Thank you for your consideration in this matter.

This memo is to inform you of action the Education Committee wishes to take in light of our interest in and recognition of the importance of this nation's founding and related documents (Declaration of Independence, U.S. Constitution and the Federalist Papers). Because of the importance of these documents and the principles underlying them, the Committee wishes to introduce legislation which will encourage school boards and the Commissioner of Educational and Cultrual Services to ensure an understanding of and practical experience with the founding documents by all Maine students.

We plan to introduce a joint order directing the Education Committee to report out a "Resolve, to Encourage the Study of the Nation's Founding and Related Documents by Maine Students" for consideration by the Second Regular Session of the 114th Legislature. A draft copy of the resolve is attached.

Resolve, to Encourage the Study of the Nation's Founding and Related Documents by Maine Students.

Whereas, the adoption of the Declaration of Independence in 1776 and the signing of the United States Constitution were principal events in the history of the United States, the Declaration of Independence providing the philosophical foundation on which the nation rests and the Constitution of the United States providing its structure of government; and

Whereas, the Federalist Papers embody the most eloquent and forceful argument made in support of the adoption of our republican form of government; and

Whereas, these documents stand as the foundation of our form of democracy providing at the same time the touchstone of our national identity and the vehicle for orderly growth and change; and

Whereas, in order to function effectively in our society, Americans need a basic knowledge and understanding about the history of our nation, the philosophies underlying its founding and the principles set forth in the Declaration of Independence, codified in the Constitution and defended in the Federalist Papers; and

Whereas, the survival of the republic requires that our nation's children, the future guardians of its heritage and participants in its governance, have a firm knowledge and understanding of its principles and history; Now, therefore, be it

- Sec. 1. Civic Literacy. Resolved: That school boards are encouraged to provide, at appropriate times, for the study by all students of the nation's founding and related documents, which shall include at least the major principles in the Declaration of Independence, the United States Constitution and its amendments, and the most important of the Federalist Papers; and
- Sec. 2. Graduation Requirements. Resolved: That school boards are encouraged to ensure that all students demonstrate knowledge and understanding of the nation's founding and related documents through community service programs in order to receive a diploma or certificate of graduation from high school; and
- Sec. 3. Application through experience. Resolved: That school boards are encouraged to provide all students with multiple opportunities to experience during in-school activities and through community-based programs exposure to the principles that exemplify the values inherent in the nations founding and related documents; and
- Sec. 4. Passing Grades. Resolved: That school boards are encouraged to include among the requirements for graduation from high school a passing grade in all courses that include primary instruction in the Declaration of Independence, the United States Constitution and its amendments, and the most important of the Federalist Papers; and
- Sec. 5. Test. Resolved: That the Commissioner of the Department of Educational and Cultural Services is encouraged to require that any Maine Education Assessment tests developed and administered beginning with academic year 1991-92 include questions related to the Declaration of Independence, the United States Constitution and its amendments, and the most important of the Federalist Papers; and
- Sec. 6. Curriculum. Resolved: That the Department of Educational and Cultural Services, the school boards and the teacher education preparation programs at post-secondary educational institutions in the state, as appropriate, are encouraged to establish curriculum content and provide for in-service and pre-service teacher training to ensure that teachers are adequately prepared and supported to carry out the intent and provisions of this resolve. The curriculum content established should include a review of the contributions made by Americans of all races during the period in which our nation was founded; and

Sec. 7. Report. Resolved: That the Commissioner of the Department of Educational and Cultural Services shall include in the annual report to the Legislature an update on the implementation of this resolve.

#### DRAFTING GUIDELINES

FOR

#### ENACTED AND COUNCIL-APPROVED STUDIES

These guidelines are to assist legislators, committees, drafters, and the Legislative Council in preparing legislation proposing a study and in producing and reviewing requests to the Council for committee studies.

Each administrative item listed should be addressed in a resolve or bill proposing a study.

The pertinent administrative items - particularly those concerning study subjects and tasks, staffing from the legislative staff, and the report - should be addressed in requests to the Council from committees for study authorization.

#### Staffing

If staffing assistance is desired:

- + Direct another state agency to provide primary staff
  - Specify who is to provide assistance in drafting study legislation

"The (state agency) shall provide staff assistance to the (study group)."

"The (state agency) shall prepare any legislation recommended by the (study group)."

or

"The (study group) shall request assistance with the preparation of any recommended legislation from the Legislative Council." - Specify who is to provide clerical assistance

"The (state agency) shall provide clerical assistance to the (study group)."

or

"The (study group) shall request clerical assistance from the Legislative Council."

or

- + Permit the employment of consultants or research assistants
- "The (study group) may contract with a (consultant or research assistant) to provide professional services for the following study activities: (designate as primary staff or cross-reference the pertinent study questions, tasks and products)."
- Specify who is to be the project manager for a consultant

"The (study group) shall request assistance with the management of the consultant's work from the Legislative Council."

or

- "The chair of the (study group) shall manage the consultant's work."
- Specify who is to provide assistance in drafting study legislation if a consultant is to provide primary staffing assistance
- "The (consultant) shall prepare any legislation recommended by the (study group)."

#### Compensation of Members

- "The members of the (study group) who are legislators shall receive the legislative per diem as defined in the Maine Revised Statutes; Title 3, section 2, for each day's attendance at (study group) meetings."
- + Include explicit authorization for reimbursement of expenses
- "All members of the Commission shall receive reimbursement for travel and other necessary expenses, upon application to the (administering authority)."

#### Report

+ Specify products

- "The (study group) may produce (a written report, a questionnaire or survey summary, an informational booklet, legislation only, etc.)."
- + Specify date for submission of report to the Legislature
- "The (study group) shall present its findings, together with any recommended legislation, to the Second-Regular Section of the 114th Legislature no later than (date)."

Legislative staff will be assigned as primary staff to a study group only if the report and legislation is submitted by Becember 1, 1989. Legislative staff will be assigned to assist the study group in drafting legislation only if the legislation is submitted by December 1, 1989. All study groups having legislative staff as primary staff must complete their work within one interim. If the group wishes to continue its study during the next interim it must submit legislation proposing an extension.
