The Legislative Council Meeting was called to order in the Council Chambers by the Chair, Speaker Martin, at 9:36 a.m.

SECRETARY'S REPORT

The Summary of the April 3, 1990, Council meeting was accepted and placed on file. (Motion by Sen. Pray; second by Sen. Clark; unanimous).

EXECUTIVE DIRECTOR'S REPORT

Sally Diamond, Executive Director, drew Council members' attention to a summary of the expenditures to date for the Study of Legislative Structure and Operations. The summary included expenditures charged to the Commission for its own activities as well as the status of payments related to the contract with Peat Marwick Main & Co. The report indicated that, to date, the Commission had spent \$2,643.96 out of its original appropriation of \$20,400; and \$145,000 has been paid to Peat Marwick, leaving a balance in the contract budget of \$5,000.

Sen. Pray, Subcommittee Chair, reported that the Subcommittee appointed by the Council Chair (Sen. Clark, Rep. Gwadosky, Rep. Cahill also attended the meeting. Sen. Pray presented a summary of the Subcommittee's recommendations to the Council.
