Motion: That the Legislative Council agrees that the legislative job classifications/positions as proposed by Edward Charbonneau et al on October 8, 2002 comprise an appropriate unit, named the Independent Association of Nonpartisan Legislative Professionals, for the purposes of collective bargaining, and authorizes the Executive Director to sign the Maine Labor Relations Board Form 1 so certifying an agreement with the unit composition and to notify the Maine Labor Relations Board so the issue of representation for the unit may proceed to an election in accordance with Maine Labor Relations Board rules.
