Tuesday, January 15, 1963

Senate called to order by the President.

Prayer by Rev. William Dawes Veazie of Gardiner.

On motion by Mrs. Christie of Aroostook.

Journal of January 10 read and approved.

Joint Order

ORDERED, the House concurring, that three hundred twenty-five (325) copies of the Legislative Record for the session of 1963 be printed and bound, one copy for each of the members of the Senate, House of Representatives, the Secretary of the Senate and Clerk of the House, and the remainder to be deposited in the State Library for exchange and library use; and be it further

ORDERED, that four hundred (400) copies of the Legislative Record be printed in pamphlet form for distribution from day to day to members of the Legislature and the State Departments, under the direction of the Document Clerk, and be it further

ORDERED, that suitable index be prepared for such Legislative Record, under the direction of the Secretary of the Senate and Clerk of the House. (S. P. 13)

In Senate, January 2, read and passed.

In the Senate, the Secretary read House Amendment A.

Mr. EDMUNDS of Aroostook: Mr. President and members of the Senate: For the benefit of the new members and also for the benefit of the older senators, I would like to state that this amendment does not refer to what we commonly call the "horse blanket", the so-called proof of the proceedings of the Senate and House that we receive on our desks every day. It refers to the preliminary bound copy of what eventually becomes the legislative record which we receive

quite a long time after the session is over with. This preliminary bound copy in pamphlet form generally comes to us too late to be of any use to members of either branch of the Legislature, and the leadership in the House feel that this is the natural place to start economy, to do away with this preliminary legislative record would save approximately \$1400 and there is a feeling that there is no value to it.

I would like to mention that in the office of the President of the Senate and also in the retiring room that the senators have on the fourth floor copies of the proofs — and I mean the so-called "horse blanket" when I say proof—which will be kept on file for the convenience of all members of the Senate. So at this time, Mr. President, I would like to move that we recede and concur with the House.

The motion prevailed, and the Senate voted to recede and concur.

Joint Order

On motion by Mr. Cole of Waldo ORDERED, the House concurring that the State Personnel Board place into effect January 26, 1963, for the classifications of Highway Maintenanceman I, Highway Maintenanceman II, Highway Maintenanceman IIA, Highway Maintenanceman III, Highway Maintenanceman IV, Highway Foreman I, and Highway Foreman II, longevity provisions in the J. L. Jacobs Company's proposals as set forth in its report to the State Personnel Board dated October, 1960 (S. P. 86)

Mr. COLE of Waldo: Mr. President and members of the Senate: The effect of this order would be to provide additional salary steps for maintenance employees of the Highway Department in instances where only one prevailing rate has been provided. This would reward long-time service by providing an advancement of one salary step to all employees in these classifications with eight or more years of service, and an additional salary step to all employees with fifteen or more years of service with the state. The cost to the Highway Department for the period January 26, 1963 to June 30, 1963 would be approximately \$85,000. This would

in effect take care of approximately 53 per cent of highway maintenance workers. 31 per cent would be in the first step, a five-cent raise and 22 per cent in the second for a fifteen-year period. I have discussed this order with the Governor and it has his approval and it also has the approval of the State Personnel Board and the State Highway Commission.

Mr. President, I move that this order lie on the table and be specially assigned for the next legisla-

tive day.

The motion prevailed and the order was laid upon the table pending passage, and was especially assigned for tomorrow.

Senate Order

On motion by Mr. Brooks of Cumberland

ORDERED, that the Secretary of the Senate be authorized to invite clergymen who may be requested by any member of the Senate to

act as Chaplains.

Mr. Lovell of York: Mr. President, might I inquire if this would include mileage for the pastor say from his home, because actually Sanford is so far and the pay of ministers is rather low you would not be able to have one up from Sanford unless his mileage was taken care of.

The PRESIDENT: The Senate hears the question of Senator Lovell.

Mr. BROOKS of Cumberland: Mr. President, it has been the custom of the Senate in the past to reimburse the clergymen that are able to be present at the opening of our session in a reasonable sum for their services.

The PRESIDENT: The Chair thanks the Senator from Cumberland, Senator Brooks, and inquires from the Senator from York, Senator Lovell, whether or not his question has been properly answered.

Mr. LOVELL: Mr. President, I believe it is a fixed fee regardless of distance however.

The PRESIDENT: The Senator from York, Senator Lovell, inquires again from any senator who may care to answer.

On motion by Mr. Brooks of Cumberland the order was tabled until the next legislative day.

ORDERED, that three thousand (3000) copies of the Governor's Budget Message be printed.
