Wednesday, January 30, 1963

Senate called to order by the President.

Prayer by Rev. Martin Perry of Woolwich.

On motion by Mrs. Harrington of Penobscot,

Journal of yesterday was read and approved.

The PRESIDENT: The Chair is happy to call to the attention of the Senate and to introduce to the Senate of Maine Mr. Edgar Harrington, who is visiting in the Senate Chamber and who happens to be the son of our good Senator from Penobscot, Senator Harrington. (Applause)

Without any inference as to your age, sir, the Chair might observe that it hardly seems possible that our good Senator could have a son of your age.

The Chair is additionally happy to introduce to the Senate of the State of Maine Miss Janice Bacon of Mercer, Maine, who was Apple Queen of 1961 and Dairy Princess of 1962. I would suggest that the Sergeant-at-Arms escort Miss Bacon to the rostrum.

#### Orders of the Day

Mr. Lovell of York was granted unanimous consent to address the Senate.

Mr. LOVELL: Mr. President and members of the Senate: I would at this time like to read into the record of the Maine Senate a commendation of a publication which has devoted much space and effort

in the interest of Maine's Economic Development. As Chairman of the legislative committee on Industrial and Recreational Development I wish to thank the Maine Trucking News for the fine work that this publication is doing for the State of Maine. It is my understanding that copies of this attractive publication are being made available to the Maine Department of Economic Development for use in the Department's efforts to secure new industries, and I think you will agree that this month's edition, carrying the stories of members of this august body and the Maine Grocery representatives constitutes a valuable contribution to our government. The reproduction of the State Seal in full color, which is done with special permission from Governor John Reed, represents the first time in recent years that such a full-color reproduction has been made, and we hope that reprints will be made for further promotion of the State.

The Maine Trucking News, incidentally, is one of only a few such publications in the United States which publishes in full color, reaching manufacturers and industrialists in many parts of the nation. It serves as a valuable promoter of Maine and its industrial potential.

Last summer our Governor Reed, in a speech to the trucking industry, stated:

"I have also been very interested and very pleased to read that your excellent publication, Maine Trucking News has lived up to its promise and there has always been much favorable reaction from many quarters. I feel that the trucking industry deserves considerable credit for its contribution to Maine's economic welfare, not only through its monthly publication but also through the continuous efforts by the Maine Truck Owners Association to assist us in serving existing industries and in acquiring new ones. It is my understanding that the MTOA recently played a key role in keeping a major industry within the State. As the wheels of progress are turning we must be watchful of all developments of importance to the State of Maine, and the Maine Trucking Industry has performed a

valuable service in keeping abreast of all new departments.

According to the figures made available to members of the Maine Legislature last week trucks now mean an annual payroll of \$241,000,000 a year and they move 42 percent of the total value of the products manufactured in Maine and they employ 61,275. This story of Maine trucks is being forcefully told through the Maine Trucking News. It is my hope that other

Maine industries will assist us in like fashion in our struggle to convince the rest of the nation that Maine is not very far away from its major markets and that this great State has much to offer in the form of industrial and recreational opportunities.
