Orders of the Day

Mr. COLE of Waldo: Mr. President, may I inquire if L. D. 645, being Bill "An Act authorizing Maine-New Hampshire Interstate Bridge Authority to Prepare Plans for Construction of an Additional Bridge and Approaches connecting Portsmouth, New Hampshire with Kittery Maine" is in the possession of the Senate?

The PRESIDENT: The Chair will inform the Senator from Waldo, Senator Cole, that it is, having been so requested by the Senator from Waldo, Senator Cole.

Mr. COLE: Mr. President: I now move that we reconsider our action whereby this was referred to the Committee on Judiciary.

The PRESIDENT: The Senator from Waldo, Senator Cole, moves that on L. D. 645, H. P. 440 the Senate reconsider its action whereby it was referred to the Committee on Judiciary. The Chair recognizes the Senator from York, Senator Lovell.

Mr. LOVELL of York: Mr. President and members of the Senate: I hate to differ with the good Senator from Waldo, Senator Cole, but this has actually very little to do

with the building of roads. It seems to me it is a matter that should go before the Judiciary Committee, which it did, according to my understanding, two years ago and has in the past.

I would like to pose a question through the Chair to the Chairman of the Judiciary Committee: Is that not correct?

The PRESIDENT: The Senator from York, Senator Lovell, poses a question through the Chair to the Senator from Kennebec, Senator Farris, who may answer if he chooses.

Mr. FARRIS of Kennebec: Mr. President, it is my understanding that two years ago the bill was before the Committee on Judiciary, but prior to that I have no knowledge.

Mr. COLE of Waldo: Mr. President, the Highway Committee now has before it another bill, L. D. 108, which is a companion bill to this one and which has already been heard, it being "An Act Relating to Construction of a Bridge to Span the Piscataqua River from Kittery, Maine to Portsmouth, New Hampshire." It would seem to me that if we are to be consistent with the Committee on Reference of Bills on their reference of bills we certainly should reconsider this one and it certainly should go to the Committee on Highways along with the other one.

Mr. LOVELL of York: Mr. President, the fact we might have a mistake on the other one in my opinion would be no reason for the Senate to make a mistake again. It seems to me that this is a Judiciary affair, if you will glance at the bill, and I would request a division on the motion to reconsider.

Mr. EDMUNDS of Aroostook: Mr. President, in support of the remarks made by the Senator from Waldo, Senator Cole, may I say that the Committee on Reference of Bills very carefully considered the committee to which this particular piece of legislation should be referred, as was the case also in a companion bill, and we feel it should properly be referred to the Joint Select Committee on Highways.

The PRESIDENT: The question before the Senate is on the motion

of the Senator from Waldo, Senator Cole, that on L. D. 645, H. P. 440 the reference of this bill to the Committee on Judiciary be reconsidered. Having voted on the prevailing side, the Senator is in order. Is there further debate?

If not, a division having been requested, all those in favor of the motion for reconsideration by the Senator from Waldo, Senator Cole, will now rise and stand in their places until counted.

A division was had.

Twenty-three having voted in the affirmative and five in the negative the motion prevailed and reconsideration was voted.

On further motion by Mr. Cole of Waldo the bill was referred to the Joint Committee on Highways in concurrence.

Mr. COLE of Waldo: Mr. President, may I inquire if bill, "An Act Extending the Powers of the Maine-New Hampshire Interstate Bridge Authority" (H. P. 439) (L. D. 644) is in the possession of the Senate?

The PRESIDENT: The Chair will state that it is, having been held at the request of the Senator from Waldo, Senator Cole.

Mr. COLE: Mr. President, I now move that the Senate reconsider its action whereby this was referred to the Committee on Judiciary.

Mr. LOVELL of York: Mr. President, I move that the bill be tabled until later in the day.

Mr. EDMUNDS of Aroostook: Mr. President, I request a division.

A division of the Senate was had. Five having voted in the affirmative and twenty-three opposed, the motion to table did not prevail.

Thereupon, the Senate voted to reconsider its former action whereby the bill was referred to the Committee on Judiciary; and on further motion by Mr. Cole of Waldo, the bill was referred to the Committee on Highways in concurrence.

The President laid before the Senate the first tabled item especially assigned for today, (H. P. 387) (L. D. 586) Bill, "An Act to Create the Georges Valley Community School District", tabled on January 30 by Senator Stilphen of Knox

pending reference, and on further motion by that Senator, the bill was referred to the Committee on Education.

The President laid before the Senate the 2nd tabled and today assigned item (S. P. 303) Joint Order Relative to Creating an Interim Joint Committee to Study the Functioning of the Department of Economic Development, tabled January 30 by Senator Edmunds of Aroostook pending passage; and that Senator presented Senate Amendment A. Which amendment (reproduced as S-3) was read and adopted, and the Order as so amended was passed.

Sent down for concurrence.

On motion by Mr. Campbell of Kennebec, the Senate voted to take from the table Bill, "An Act Relating to the Joint Bank Account Law and the Inheritance Taxation of Joint Bank Accounts" (H. P. 539) (L. D. 756) tabled by that Senator earlier in today's session pending reference to a committee.

Mr. CAMPBELL of Kennebec: Mr. President, I honestly believe that the subject matter of this bill is something that is appropriate for consideration by the Judiciary Committee, and having checked with the leadership and the Chairman of the Legal Affairs Committee, I now move that this bill be referred to the Committee on Judiciary in non-concurrence.

The motion prevailed.

Sent down for concurrence.

On motion by Mr. Edmunds of Aroostook, the Senate voted to take from the table Bill, "An Act Relating to General Penalty for Violation of the Insurance Laws" (S. P. 318) tabled by that Senator earlier in today's session pending motion by Mr. Brown of Hancock that the bill be referred to the Committee on Business Legislation; and Mr. Edmunds moved the pending question.

Thereupon, the bill was referred to the Committee on Business Legislation in non-concurrence.

Sent down for concurrence.

On motion by Mr. Brown of Hancock, the Senate voted to take from the table Tabled Item 3 (H. P. 5) (L. D. 11) Resolve Regulating Salmon Fishing in Tunk Lake, Hancock County and Nahmakanta Lake, Piscataquis County, tabled on January 30 by Senator Brown of Hancock pending assignment for second reading; and that Senator presented Senate Amendment A and moved its adoption.

Which amendment was read and adopted, and the resolve as so amended was tomorrow assigned for second reading.
