The PRESIDENT: The Chair is most pleased at this time to recognize in the Senate Chamber Troop 1 of the Boy Scouts of America from Brewer, Maine in Penobscot County. This is the first Boy Scout troop organized in the United States and all of the boys present are either Star or Life Scouts. Those of the Senate who have had scouting experience will know that this is a real and unusual accomplishment; that a boy who becomes interested in the greatest youth movement in the United States starts off as a Tenderfoot, if he complies with certain requirements: he moves from that position to Second-class Scout, and by continuing his interest and his education and his work he may become a Firstclass Scout, whereupon he begins to work for his Merit Badges, socalled; and at least it used to be that if you earned five Merit Badges you become a Star Scout: if you earn five more and thus have ten you become a Life Scout. and the next award is Scouting's highest honor, that of Eagle Scout. This Troop is accompanied by the Troop Chairman, Judge Wesley Archer of Brewer, who was a former member of this Legislature.

I would like to point out to you young men some facts which I would like to have you remember.

In the State of Maine we have 17,000,000 acres of forest land; we have a coast line of bays and coves and inlets of 2400 miles, nearly one-half the entire Atlantic coast line of the United States; we have 2500 lakes and ponds; we have 5000 streams and small rivers; we have five major rivers; we have approximately 970,000 people in 33,-000 square miles, nearly as large an area as all of the five New England States combined.

The Senate of the State of Maine before which you now appear is aware of these facts and would hope that as you go through life you will keep these things in mind, and that you will not only remember your Scout oath and Scout lore but will remember these mighty important facts of the State in which you live, and as you build your character in the future help build this State too.

I would like to introduce to you the Senators from Penobscot County who represent your area: Senator Atherton, Senator Philbrick, Senator Harrington and Senator Whittaker. (Applause)

Eighty-seventh Congress of the United States of America

At the Second Session

Begun and held at the City of Washington on Wednesday, the tenth day of January, one thousand nine hundred and sixty-two

JOINT RESOLUTION

Proposing an amendment to the Constitution of the United States relating to the qualifications of electors.

Resolved by the Senate and House of Representatives of the United States of America in Congress assembled, That the following article is hereby proposed as an amendment to the Constitution of the United States, which shall be valid to all intents and purposes as part of the Constitution only if ratified by the legislatures of three-fourths of the several States within seven years from the date of its submission by the Congress:

'ARTICLE -

'Section 1. The right of citizens of the United States to vote in any primary or other election for President or Vice President, for electors for President, or Vice President, or for Senator or Representative in Congress, shall not be denied or abridged by the United States or any State by reason of failure to pay any poll tax or other tax.

'Sec. 2. The Congress shall have power to enforce this article by appropriate legislation.' "

Ratification of Amendment to the Constitution of the United States relating to the Qualification of Electors

In the year of our Lord one thousand nine hundred and sixty-three

Resolution, Ratifying the **Pr** oposed Amendment to the Constitution of the United States Relating to the Qualification of Electors.

WHEREAS, the Eighty-seventh Congress of the United States of America, at the second session begun and held at the City of Washington, on Wednesday, the tenth day of January, one thousand nine hun-

dred and sixty-two, by a constitutional two-thirds vote in both Houses adopted a Joint Resolution proposing an amendment to the Constitution of the United States, to wit:

Joint Resolution

Proposing an amendment to the Constitution of the United States relating to the qualification of electors.

Resolved by the Senate and House of Representatives of the United States of America in Conassembled (two-thirds of gress each House concurring therein), That the following article is hereby proposed as an amendment to the Constitution of the United States, which shall be valid to all intents and purposes as part of the Constitution only if ratified by the legislatures of three-fourths of the several States within seven years from the date of its submission by the Congress:

"ARTICLE -

"Section 1. The right of citizens of the United States to vote in any primary or other election for President or Vice President, for electors for President or Vice President, or for Senator or Representative in Congress, shall not be denied or abridged by the United States or any State by reason of failure to pay any poll tax or other Tax.

"Section 2. The Congress shall have power to enforce this article by appropriate legislation."

THEREFORE, BE IT

RESOLVED, that the Legislature of the State of Maine hereby ratifies and adopts this proposed Amendment to the Constitution of the United States.

RESOLVED, that the Secretary of State of the State of Maine notify the President of the United States. the Secretary of State of the United States, the President pro tempore of the Senate of the United States, the Speaker of the House of Representatives of the United States. the Administrator of General Services of the United States, and each Senator and Representative from Maine in the Congress of the United States of this action of the Legislature by forwarding to each of them a certified copy of this Resolution. Orders of the Day

The President laid before the Senate Item 6-14, Bill "An Act Relating to Premarital Medical Examinations," (S. P. 66) (L. D. 42) which was tabled by the Senator from Kennebec, Senator Farris, earlier in today's session.

Mr. FARRIS of Kennebec: Mr. President, this L. D. 421, "An Act Relating to Premarital Medical Examinations" seems to be a measure which would have a great deal of effect upon the public here in the State of Maine, particularly with the progress of medical science whereby man is living to an age of many more years than previously. We have always tried in the State of Maine to improve our health standards, and this measure on the face of it would seem to be lowering our health standards, and I would very much appreciate it if either Senator Porteous or Senator Hinds by request through the Chair would please explain why this measure has been brought before the legislature and the reason for it.

The PRESIDENT: The Senator from Kennebec, Senator Farris, poses a question through the Chair to the Senators from Cumberland County, Senator Porteous and Senator Hinds, either one of whom may answer if they choose.

Mr. HINDS of Cumberland: Mr. President, I direct this answer to Senator Farris.

The reason for the change of this law is to not make the Department check to see if a doctor was a graduate of a Class A medical school, because having to check on each one of these all around the country, because doctors graduate from schools all over the country and all over the world, this creates a problem for the Department and they have not been able to enforce this law.

As far as the 60-year limit was concerned, I questioned the same thing at the hearing and Dr. Fisher informed me that this is what is done in most other states, and they just picked this age because it was this way in many other states. The age could be any particular age. The main part of this bill is for the Class A medical school, so that the Department does not have to check up to make sure that a doctor graduated from a Class A medical school.

Mr. FARRIS of Kennebec: Mr. President, I thank the Senator from Cumberland, Senator Hinds, and I at this time move the pending question.

The motion prevailed and the "Ought to pass" report of the Committee was accepted, the bill was given its first reading and tomorrow assigned for second reading.
