# SENATE

Thursday, February 7, 1963

Senate called to order by the President.

The PRESIDENT: Members of the Senate: I would like to ask you to pause for a few moments in our deliberations today to join me in paying respect to a very worthy group of Maine citizens. Today is the beginning of National Boy Scout Week. From now until February 13th, throughout the State, Scouts and Leaders - from eight to eighty — will be taking part in various activities which will highlight the importance of the Boy Scouts of America. Tomorrow, February 8th, is the 53rd Anniversary of the founding of this great American institution.

If we give this space to one committee we should be obligated to give it to all committees, therefore I move, Mr. President, the indefinite postponement of this order.

The motion prevailed and the order was indefinitely postponed.

The PRESIDENT: The Chair lays before the Senate Item 6-32, Bill, "An Act Providing Expense Reimbursement for Members of the Legislature," which was tabled by that Senator earlier in the day.

Mr. Farris of Kennebec requested and was granted unanimous consent to address the Senate.

Mr. FARRIS: Mr. President and members of the Senate: I was not aware that this measure was to be before us this afternoon until I saw the calendar when I came in here. The reason I requested unanimous consent — I will make a tabling motion and I realize it is not debatable, and I certainly do not wish to—

would inform the Senator that the tabling motion, if one is to be made, cannot be made even under unanimous consent to address the Senate. If the Senator from Kennebec is to restrict his remarks to tabling of any bill the Chair will not allow him to proceed, but if he has remarks to address to the Senate on the subject-matter of the bill in question he may proceed.

Mr. FARRIS: Thank you, Mr. President. The reason for leaving the chamber was to confer with the Attorney General in regard to the question of constitutionality and legality of this measure as drafted. I was advised that there is an amendment prepared to be offered but the person who has the amendment does not have it ready for presentation yet, and he wished to have the bill go through its first and second reading and then the amendment would be offered. This amendment had been prepared by the Attorney General's Department, and I asked the Attorney General another question, as to whether or not he had given any consideration to the effective date of this legislation and he said, "No," and it raised some questions in his mind, even with the amendment, as to whether or not this measure would be legal.

It certainly would be very irresponsible if we were in haste to enact legislation such as this without thoroughly checking the legal aspects. I would certainly be embarrassed as Chairman of the Committee on Judiciary if a measure were to be enacted or even given first reading, to find out at a later date that there are legal ramifications which prohibit such legislation from being enacted. Even though I cannot make a tabling motion, inasmuch as I have made these remarks I would dislike to see this proposition buried; I think it should be kept alive, but as the matter now stands I would be in a position where I would have to vote against passage in the event that comes up for discussion today, but I would hope that the proponent of this measure would put this upon the table for a reasonable length

of time, even until Tuesday, so that we can check the legal aspects.

On motion by Mr. Hinds of Cumberland the bill was tabled and especially assigned for Tuesday next. The adjournment order having been received from the House, the Senate adjourned until 10:00 A.M. next Tuesday.
