Wednesday, February 20, 1963 Senate called to order by the

President.
Prayer by Rev. A. Christopher

Ives of Hallowell.

On motion by Mr. Lovell of York, the Journal of yesterday was read and approved.

The PRESIDENT: The Chair is happy to recognize in the Senate Chambers the daughter and grand-children of our good Senator from Washington, Senator Wyman. Will Mrs. A. Warren Wilkinson and the two children stand and be recognized? (Applause)

The Chair would also like to recognize Mr. Stephen Saliba, a young man from Bangor who is the grandson of Maurice Knowles, our congenial doorkeeper, and the Chair would like to appoint Steve as an honorary page for today's session.

(Applause)

The Chair also recognizes in the Senate Chamber Ex-Senator Bowker and his good wife. Would he and she please stand and be recognized?

(Applause)

Of course the Senate is always happy to recognize any young lady who represents as a Queen one of the State's leading industries. Today we have with us the State's Apple Queen. Her name is Mary K. Webber and she is from North Anson. I would like to have the Sergeantat-Arms escort her briefly to the rostrum.

Miss Webber was thereupon escorted to the rostrum by the Sergeant-at-Arms, amid the applause of the Senate, the members rising.

Miss MARY K. WEBBER: Good morning. I was a bit at a loss for words as to how I was going to make a five-minute speech on various ways of using apples and making it fairly interesting.

The majority of you or your wives are probably already aware of them and have your own favorite dish, so Sunday, quite by accident, I came up with another idea: "Controlled atmosphere apple storage," Controlled atmosphere apple storage, called "C.A." for short is a method for keeping apples longer by refrigeration, reduced oxygen and

above-normal carbon dioxide. It was originally developed in England in the late nineteen-twenties and early thirties as a means of keeping the life of the apple longer. The first C.A. commercial plant for the Mc-Intosh apple was built in the nineteen-forties in New York.

My parents and I had stopped at the Lakeside Orchards in Manchester on Sunday. I asked Dad if he would please ask the proprietor about any available pamphlets on apples. He did so and explained the reason why. We were invited in and given a tour of the storage building, Mr. George Powers, the owner, explained everything as we went along. His first storage shed holds 8000 bushels. It is not yet completed but the air is kept cool and circulating. The second storage shed holds 12,000 bushels. This is full and airtight. The walls, floor, ceiling and door are of double thickness. As soon as the room is full and the door closed and carefully sealed it is not re-opened for another 90 days. During this time the apples sleep and are kept as crisp and fresh as the day they were picked. Normally there is 21 per cent oxygen in the air, but by the end of the first twenty days of storage this percentage must lowered to 5 per cent. Mr. Powers does this by means of a limer, often called a breather bag. In this case it is a large tin box about six feet by twenty-five feet by four feet with two ventilators, one at the top, one at the bottom. This apparatus is outside the C.A. room and is filled with lime. The ventilators are connected to the room. The carbon dioxide given off by the apples is heavier than the oxygen, therefore falling to the bottom of the venti-lator. This goes through the lime and comes back into the C.A. room as fresh oxygen. This is controlled by the opening or closing of the ventilators. As I said before, the oxygen percentage must be lowered to 5 per cent at the end of the first twenty days, and for the re-maining period of time it is kept between three and four per cent.

I realize I have only lightly touched the subject of controlled apple storage but I hope I have said enough to make it understandable. Thank you. (Applause)

Mr. LOVELL of York: Mr. President, I would like to move that the minority report be accepted, and to speak briefly on the motion.

The PRESIDENT: The Senator may proceed.

Mr. LOVELL: Mr. President and members of the Senate: I would ask you to turn to L. D. 145 in your books and note that the addition on this, which is a department bill for the purposes of research and development for industrial and manufacturing enterprises or associations thereof.

Maine is going to enter the space age in the near future. We are certainly trying in Maine to get new industry in here, and we need to get industry in here for the manufacture of durable products, which will be permanent employment.

Now this change in this bill was misconstrued by the committee, they thinking that the Maine Industrial Building Authority would be going out and building buildings for the University of Maine or some of our universities or vocational colleges or teachers' colleges under Maine Industrial Building Authority, but actually they did not realize that under the Maine Industrial Building Authority that the non-profit organization which builds a building in a community has to put up ten per cent, and the other ninety per cent is guaranteed by the State under MIBA and the money put up by some company, some insurance company that the State has agreed to go along with through the Maine Industrial Building Authority.

Now this would not mean that any university, under their rules and regulations, could build a building under Maine Industrial Building Authority, but this would give industry in Maine, for example, such as Raytheon — if the Raytheon Company wanted to build a building to do research work in, which eventually would result in many jobs; or if we got a contract from the National Aeronautics Space Administration for a research and development program here — not to manufacture goods but for a research and development program.

then profit organization and the community putting up ten per cent and then MIBA guaranteeing the other ninety per cent they could build this industrial building for the purpose of research. It would not be directly for manufacturing, but it would mean the employment of a lot of people and at the same time it would be a general over-all help in the getting of industry into the State of Maine. So I would urge the Senate to go along with the minority report on this. I assure you that it is really important that this bill be incorporated in the Maine Industrial Building Authority. move for the acceptance of the minority report.
