#### Orders of the Day

On motion by Mr. Wyman of Washington, the Senate voted to take from the table the 25th tabled and unassigned item (H. P. 308) (L. D. 401) bill, "An Act to Correct Errors and Omissions in the Public Laws Relating to Sea and Shore Fisheries"; tabled on February 21st by that Senator pending enactment.

Mr. WYMAN of Washington: Mr. President and members of the Senate: This bill disturbs me. It is under the title of "An Act to correct errors and omissions in the Public Laws relating to Sea and Shore Fisheries", yet in one section it provides that when a fisherman, a lobster fisherman or a crab fisherman is convicted in the lower court and appeals the conviction, that the Commissioner may suspend his license or his right to obtain such license until the case has finally been heard in a higher court.

It would seem to me that in such a case it would be possible for a fisherman to have his license suspended perhaps during a whole summer, to lose his work during the summer, and then perhaps to be found not guilty. Further, it seems to me that a provision of this nature should be in a separate bill and should be given a full hearing. Therefore, I present Senate Amend-

ment "A" and move its adoption. This amendment would delete that section from this L. D. 401.

On motion by Mr. Wyman of Washington the Senate voted to reconsider its former action whereby the bill was passed to be engrossed; and on further motion by the same Senator, Senate Amendment A (S-43) was read and adopted and the bill as amended was passed to be engrossed.

Sent down for concurrence.

On motion by Mr. Farris of Kennebec, the Senate voted to take from the table Item 6-31 on page 4 of today's calendar, Bill "An Act Exempting Proceeds of Pension and Profit Sharing Plans from Inheritance Tax Law" (H. P. 7) (L. D. 13); tabled by that Senator earlier in today's session pending assignment for second reading; and on further motion by the same Senator, the bill was tomorrow assigned for second reading.

Mr. Johnson of Somerset was granted unanimous consent to address the Senate.

Mr. JOHNSON: Mr. President and members of the Senate: I would like to call your attention to the Food Section of the Miami News, which I believe was on your desks this morning.

Week before last. Representative Littlefield and myself went to Miami to observe, as guests of the Department of Economic Development. There were no restrictions placed upon our travel in any way. shape or form in regard to attending any other affairs, but, being good legislators - and particularly Mr. Littlefield is a very conscientious legislator - we did our job. We went to the Boat Show and observed, and we would like to report back that the first day of the Boat Show 32,000 people passed the Maine booth there. I have been to boat shows in many places and this was probably the best show that I have ever seen. There were many people that asked questions about Maine, indicating a desire to come up here.

I would like to refer again to this page here. There was no accident in the fact that it was in this newspaper. It took a great deal of planning, long-range work, we will say, and the dedicated effort of several members of the Department of Economic Development.

The dinner that we attended for newspaper men and others was attended by our Governor, who did an excellent job on selling the State. It was on television and radio that night, as well as in other newspapers. Of course all this was free.

I hope you have read this column. It talks about Maine lobster, it talks about Maine peas, it talks about Maine potatoes, and it talks about Maine apples, and there may be some other items in there. The circulation of this paper is approximately 150,000 copies.

These people in Florida, as you know, are people who come there from all over the world. I would commend the Department of Economic Development for their effort and their time and their duty that they did on this operation. Of course some of you will say that we were brain-washed a little bit, but I would like to say that they stayed away from us as though we had the plague. What we did find out we were very pleased with and perhaps a little bit surprised. We also went down with the idea that we were going to see some of these good-looking women in Florida—we had seen them in newspapers and on television and in motorboat manuals, but we came back with the idea that Maine has the most beautiful women in the country.

I would like to thank the Senate for giving me this privilege of going down. As I say, the DED did an excellent job with the little dollars they were able to use for this proposition. Thank you. (Applause)
